To my knowledge, no other chapter in TREA has received 10 awards in two consecutive years.

We will continue to follow our main objectives and recruiting new members. Chapter 58 has lost more than 200 members since I join in 1989.

I received from TREA Headquarters the 2012 scholarship applications. So if you have someone in your family that qualifies, do not hesitate to notify any board member or me. The postmark deadline for submitting applications is April 30, 2012.

If you are traveling by air this year it's good to know that the president signed a that the president signed a bill into law Jan. 3, 2012, that streamlines airport-screening procedures. This applies to service members and their families traveling on official orders, Honor Flight veterans and partners with the Defense Department to expedite the travel of wounded warriors and their families.

The next Honor Flight from the Tampa Bay Area to Washington, D.C., is schedule for April 2012. If you are a World War II veteran you may qualify for this important event. For more information, contact Chapter 58 1st Vice President Leonard Black at 813-949-6192.

Among the changes approved at TREA's National Convention in Reno, Nev., in Septembers 2011 — one you will notice — is that TREA is now "The Enlisted Association." We are reaching out not only to enlisted retirees from all the branches, but also to senior enlisted members still on

active duty. Also, to encourage younger members to join, service members with seven years of service now can join the organization. Another change that began Jan. 1 is an increase in the TREA National dues; dues are now \$30 per year, \$45 for 3 years and \$400 for a life membership. Chapter's dues are still \$10 per year.

I urge all chapter members and member-at-large to get involved and help our chapter grow by participating in our activities and spreading the word to other retirees of the mission of TREA, The Enlisted Association.


## "The Meeting Place"

### TREA: Fighting for You in 2011-2012

2011 was a busy year for TREA in Washington, D.C. Working in close cooperation with the other members of The Military Coalition and the National Military/Veterans Alliance, TREA accomplished the following:

- Won full funding for Defense health care for FY 2012.
- Won passage of the VOW to Hire Heroes Act, a bill that provides tax incentives and other measures to increase the hiring of veterans.
- Won passage of the FY2012 National Defense Authorization Act which included: 1.6% military pay raise, early retirement and voluntary separation incentives to reduce the need for involuntary separations during the coming force reductions, enhanced Yellow Ribbon Reintegration Program for wounded warriors and their families, safeguards for reemployment rights for Guard members ordered to full-time duty under state orders, death gratuity and related benefits for Guard/Reserve who die during an authorized stay at their residence during or between successive days of inactive duty training.

### Here's a partial list of what TREA is fighting for in 2012:

- Stop the Administration's proposal to impose an annual enrollment fee for TRICARE For Life.
- Stop the proposal to increase co-pays for prescription drugs
- Stop the proposed increases in enrollment fees, co-pays and deductibles for retirees under 65
- Stop any cuts in funding for the Department of Veterans Affairs
- Stop the scheduled 30% cut in Medicare/TRICARE payments to doctors
- Stop the increase in the amount you must pay in the event of a catastrophic medical issue
- For lower Guard-Reserve retirement age
- For full concurrent receipt for all VA rated disabled retirees, including those with less than 20 years of service.

The greatest economic downturn since the great depression, the growing federal deficit, divided government in Washington and the coming elections have caused the President and the Congress to now look seriously at freezing or cutting all federal spending. As a result legislation has been passed that will force massive cuts to be made in the DoD budget. Since the budget of the Department of Defense is over half of all the discretionary spending of the federal government it is a natural target for cutting back on spending.

Having TREA members supporting us at the grass-roots level is critical to our success. Never has there been a more important time for military retirees to stick together in order to protect their hard-earned benefits.

### Some Vets Should Reapply for Disability

Week of January 30, 2012

Stars and Stripes reports that the Department of Veterans Affairs (VA) is beginning a phased mailing of information packets on the Physical DisabilityRevieBoard (PDBR) to every qualified veteran with a current home address on file at VA. The Physical Review Disability Board (PDRB) has the authority to reexamine the files and, if appropriate, raise disability ratings of up to 77,000 veterans -- those medically separated with ratings less than 30 percent between Sept. 11, 2001, and Dec. 31, 2009.

Eligible veterans can apply now to the PDBR to have their ratings reviewed.
