#### They Dared To Fly

Fantasy of Flight hosted They Dared to Fly, an February 7<sup>th</sup> - 9<sup>th</sup>.

In honor of Black History Month, They Dared to Fly was featured as the first part of Legends & country, no matter how it treated them. The three men Legacies, a symposium series. The airmen spoke on their experiences with racism, integration and the movies meant to capture their part of history.



Barrington A. Irving Jr.

The youngest and first black person to pilot a plane solo around the world, Barrington A. Irving Jr., moderated the panels. Irving started out with a quote by Craig Wiesner, an historian.

"The Tuskegee airmen fought two enemies, those against whom we were waging war, and their own American compatriots, whose prejudice and discrimination provided a daily reminder that the land of the free and the home of the brave were still a land and home bitterly divided."



Col. Charles McGee remembers one winter when 178 white pilots were forced to land on his base. Determined to maintain segregation, these men tried to sleep in their planes. Come 10 p.m., many of them came knocking on doors for more comfortable accommodations. This group had to stay for four nights to wait out the storm.

While integration was a positive result of these events, it was not the goal of the Tuskegee airmen. "We didn't go into it thinking, 'We're going to set the world on fire," McGee said.

Kenneth Penman, a 62-year-old air force Veteran exhibit featuring three of the Tuskegee Airmen, from the audience, asked "How did you fight for a country that wouldn't fight for you?"

The overall consensus was that America was their wanted to fight for America. Lt. Col. George Hardy said he had no doubts about going into service because, as McGee said, America was the only country they knew.

"A lot of people thought because we were black, things were different," Lt. Col. Leo Gray said.

As Gray said, everyone had to be cream of the crop, white or black. Only above average people, mostly college graduates went into the Tuskegee Airmen program. A prerequisite for jet pilot training was to take a year of college courses. Many of the airmen did great things after retiring. Cliff Warden, one of the airmen, was the first black CEO of a Fortune 500 company.

On how these three men ended up flying planes, McGee and Gray said they had only seen planes in the movies. Gray compared pilots in those days to astronauts in modern times. Hardy built planes growing up and had not even driven a car before piloting a plane. Hardy passed the cadet exam at 17 and started flying planes at 18.

These men were 18 a long time ago, and since then, movies have been made in their honor. Gray had the most to say about these movies, especially "Red Tails," a 2012 Hollywood film. Gray recommended the HBO film "Double Victory" and the documentary "In their Own Words."

One of the audience members from a student group asked if these men felt going into WWII was the right decision. Gray felt it probably was.

Penman, who drove all the way from Miami to Polk City to see the airmen, called the men national treasures and wanted to thank them for their service.

Trent Johnson, 48-year-old retired Air Force Major, brought his ROTC students from Andrew Jackson High School in Jacksonville so they could experience living history by meeting the men who paved the way for their service in the military.

"I wanted my students to see the sacrifices the Tuskegee airmen made so they can have the lifestyle they have today," Johnson said.

Despite the hardships of the time, McGee, Hardy and Gray agreed that they made the right choice by joining the Tuskegee airmen. McGee made a reference to the movies about the airmen when telling the audience how he felt.

"I couldn't have written a script for better opportunities."

#### Support Grows For U.S. 'Drone Court' To Stop Lethal Strikes On U.S. Citizens

During a fresh round of debate over Obama's claim that he can unilaterally order lethal strikes by unmanned aircraft against U.S. citizens, some lawmakers proposed a middle ground: a special federal "drone court" that would approve suspected militants for targeting.

While the idea of a judicial review of such operations may be gaining political currency, multiple U.S. officials said that imminent action by the U.S. Congress or the White House to create one is unlikely.

#### CAIR-NJ Seeks Hate Crime Probe Of **Graffiti At Muslim Student Group's Office**

The New Jersey Chapter of the Council on American-Islamic Relations (CAIR-NJ) called on state and federal law enforcement authorities to investigate anti-Muslim graffiti found on a Muslim student group's office door as a hate crime. CAIR-NJ said someone drew an image of planes hitting the World Trade Center on the door of the Muslim Student Association's office in the Montclair State University Student Center. The university's Bias Response Team is looking into the incident.

Military Kids Web Site Also Helps Parents, Educators



The Defense Department's web site for military children has added new features to help parents and educators explain difficult topics of the military lifestyle to children.

Since its launch in January 2012, www.MilitaryKidsConnect.org has served more than 125,000 visitors and won five industry excellence awards. To mark the one-year anniversary, the web site added new content designed for children, parents and educators, officials said. The new features include:

- Military culture videos and lesson plans for teachers, school counselors, and educators to better understand the differences between military and civilian youth;
- Graphic novels and mini-documentaries by military kids sharing their experiences, and;
- New modules for children and parents on handling grief, loss and physical injury. The web site, created by the Defense

Department's National Center for Telehealth and Technology, known as T2, uses innovative ways to help military youth cope with the unique strains of military life. In addition to disruptions from parents deploying to assignments away from home,

military children are affected by moving frequently, changing schools and making new friends. They also have to live with readjustment issues when a parent returns from deployments. These issues may include post-traumatic stress and physical disabilities.

"After watching the interaction with kids on MilitaryKidsConnect this past year, we saw many conversations about trying to understand the issues they live with," said Dr. Kelly Blasko, a T2 psychologist. "We developed the added features to help parents and teachers answer the questions the kids were sharing with each other."

Blasko said the web site is continuing to add features and information to military children with the special challenges of living in a military family. Separations, moving and changing friends frequently may be unusual for civilian children, but it's a normal lifestyle for military children. The web site helps them live in that world and, hopefully, makes it more fun for them, Blasko added.

The National Center for Telehealth and Technology serves as the primary Defense Department office for cutting-edge approaches in applying technology to psychological health.

#### **Pentagon Cutting Jobs, Maintenance Due** To Budget Fears



The Pentagon has begun laying off many of its 46,000 temporary and contract workers and delaying maintenance on aircraft and ships to slow spending due to fears it may be hit by new budget cuts, Deputy Defense Secretary Ashton Carter said. The Pentagon also plans to formally notify Congress in the next few weeks that if further budget cuts take place on March 1, it will furlough most of its 800,000 full-time civilian employees, probably by asking them to take a day off per week for the last 22 weeks of the fiscal year, Carter said.

#### **Gerald R. Ford Reaches Key Milestone**

The 60-foot long, 30-foot wide island was the 452nd lift of the nearly 500 total lifts needed to complete the aircraft carrier.

#### **UAVs Could Help Safeguard U.S. Highways OR Big Brother Is Watching**

A recent project to study the use of unmanned aerial vehicles to aid in the patrolling of the 4 million miles of U.S. highways has received a grant from the Federal Highway Administration and the Georgia Department of Transportation. Javier Irizarry, director of the CONECTech Lab at the Georgia Institute of Technology, said that UAVs equipped with small cameras could inspect bridges or survey traffic conditions.

Meanwhile, flight training schools and community colleges have added courses on unmanned aerial vehicles. The FAA predicts that more than 10,000 UAVs will be operating in the U.S. in the next few years. While only three schools offer full degrees in UAV piloting, more than 350 other programs offer other training for UAVs.

**USS Thach Deploys To 4th Fleet In Support Of Operation Martillo** 



The Oliver Hazard Perry-class frigate USS Thach (FFG 43) arrived Jan. 20 to the 4th Fleet's Area of Responsibility (AOR) for a scheduled six-month deployment to conduct Operation Martillo.

Thach's crew of 220 sailors and its embarked Coast Guard Law Enforcement Detachment Team (LEDET) will conduct Counter-transnational Organized Crime (C-TOC) operations designed to improve maritime stability within the region and protect free use of the sea lanes by thwarting the activities of drug traffickers and criminal organizations.

#### **Air Mobility Command Investigates** Airman's Death At Macdill AFB



The Air Mobility Command has convened a ground accident investigation board (GAIB) that will look into the death of Staff Sgt. Emily Elizabeth Clayburn earlier this month at MacDill AFB, Fla. Clayburn died on Jan. 14 in a mishap on the supply loading dock at the base. The 29-year-old airman from Palatine Bridge, N.Y., was a member of MacDill's 6th Logistics Readiness Squadron.

"There is not yet enough evidence gathered to draw any conclusions as to the cause of this accident. Additional information will be released as it becomes available," states the AMC's release.

Lt. Gen. Robert Allardice, the AMC's vice commander, convened a safety investigation board (SIB) immediately after the accident to determine the cause and recommend measures to prevent a recurrence. The SIB will not produce a publicly releasable report, according to the AMC. There will be a publicly released version of the GAIB report after Allardice approves it and AMC officials have personally presented its findings to the Clayburn family, states the release.

Staff Sgt. Clayburn was laid to rest on Jan. 21, at the Evergreen Cemetery, in Fonda, N.Y.

#### The Good [Marine Corps] Wife Vs. The Airmen Gear Up For B-1 Modification **United States Of America**



On July 31, 2008, Col. Michael Ross Stahlman, USMC, was found in his room at Camp Ramadi, Iraq with a gunshot wound to the left side of his head. The right-handed colonel died on . 5, 2008. Despite the fact that he never suffered from depression, within hours, investigators labeled the shooting a suicide attempt. They have stuck with that finding to this day, leaving his widow to bear the task of finding the

As a Marine Corps wife, Kimberly Stahlman packed up and moved more times than most people could stomach. With each move, she immersed herself into her husband's lifestyle and kept the home fires burning all over the world. While the colonel was climbing the Marine Corps ladder, she put her master's degree in psychology to work by helping to develop the first victim's advocacy group in Okinawa, Japan. She also joined other officers' wives in organizing charity fund-raisers and attended endless social events to promote her husband's career. She even stepped forward to assume the role of president of the Parris Island Officers' Spouses Club when it was near collapse because nobody else wanted to assume leadership. She did all of this after enduring a difficult childbirth that left her with multiple health problems. In short, she was the epitome of a good Marine Corps wife.

Today, however, Kimberly is a Marine Corps widow and has come to believe that a widow's life is one the Marine Corps wants her to live in the shadows. In actuality, she would like to oblige them, but looming large is the ongoing investigation she has conducted into her husband's death. From the beginning, Kimberly didn't believe her husband shot himself and the Naval Criminal Investigative Service (NCIS) made it quite clear that she was on her own in pursuit of any other conclusion. Consequently, she joined forces with forensic experts and amassed considerable scientific evidence alleging that her husband was murdered. Despite this, the NCIS has stubbornly refused to consider the new evidence, and informed Kimberly "she could not change their minds no matter what kind of evidence she presents."

Left with no alternative, on Jan. 16, 2013, she filed an Administrative Procedures Action - or APA with the U.S. District Court in Maryland. The APA is a law which allows a federal judge to review and reverse the decisions made by governmental agencies. Kimberly's lawsuit accuses the defendants, who include the NCIS and the Secretary of Defense with "acting in a manner that is arbitrary, capricious, an abuse of discretion, or otherwise, not in accordance with law."

The suit goes on to allege that investigators "conducted little or no investigation" into at least 20 different matters that would have accompanied a thorough investigation and followed DOD directives. Among them, the number of bullets remaining in the colonel's 9-mm. Apparently, the NCIS never counted them and subsequently did not examine his bloodsoaked mattress for the presence of a second round. In addition, the suit claims that the blood spatter trajectory contradicts the NCIS' findings. It seems that Col. Stahlman's blood sprayed in a different direction from the bullet that the NCIS claims killed him. According to the forensic expert, Michael Maloney, this is an impossibility because blood always follows the same path as the bullet that causes the injury.

Whoever the judge deciding the APA turns out to be, he or she will be hard-pressed to not take Kimberly Stahlman seriously. After all, there is a certain irony to her steely determination. Life in the Marine Corps taught her to stand strong in the face of adversity even when the odds are stacked unfavorably. She lives the motto "Semper fi" and as a good Marine wife, has remained faithful. But unlike the Corps, she refuses to dishonor her husband by allowing a substandard investigation to go unchecked.

#### Boy Scouts Of America Delays Vote On **Lifting Gay Ban**



The Boy Scouts of America delayed to May a vote on whether to end a long-standing controversial ban on gay participants, giving a membership deeply divided by the possible change more time to air their concerns. Board members for the private youth organization, which turns 103 years old tomorrow, had been expected to vote on the matter at a meeting Feb 6<sup>th</sup>. Members of the 337th Test & Evaluation Sqdn are gearing up for the largest B-1 Lancer modification in program history, as part of the Integrated Battle Station and Sustainment-Block 16 upgrade.

Because of the magnitude of this upgrade, additional work is being done to make sure members of the 337th TES are ready to test and develop tactics needed to take full advantage of the new equipment and software.

Sustainment-Block 16, or SB-16, includes significant upgrades to the B-1, including the Fully Integrated Data Link and Central Integrated Test System in the aft station and the Vertical Situation Display Upgrade in the front station. Included under the umbrella of SB-16, the B-1 will also receive navigation, radar and diagnostic upgrades.

The VSDU upgrades the B-1's forward cockpit by replacing two un-supportable, monochrome pilot and co-pilot displays with four multi-functional color displays, giving the pilots more situational awareness data in a user-friendly format.

#### Florida Airport Home To Working **Propeller Planes**

A dozen large propeller planes - including Douglas DC-3s and Convair 340s - are still in use at Opa-Locka Executive Airport in Dade County, Fla. The planes, which were the airlines' and military's workhorses of the 1940s and 1950s, fly cargo and sometimes respond to oil spills.

Opa-Locka's airport is steeped in aviation history; was Amelia Earhart's starting point when attempting to fly around the world in 1937, and was home to a Naval Air Station during World War II. Today, it's the home of Coast Guard Air Station Miami, and the headquarters of the Florida Wing of the Civil Air Patrol (CAP).

#### Pentagon Will Extend (Some) Benefits To Same-Sex Couples



The Pentagon has decided to extend certain benefits to the spouses of gay and lesbian personnel, according to officials and people notified about the decision, responding to the increasingly vocal appeals of same-sex couples in the military. The military expects to announce the decision soon.

Officials at the Pentagon would not say which new benefits the department has determined it can extend to same-sex couples without violating the Defense of Marriage Act (DOMA), a 1996 law that bars the federal government from legally recognizing same-sex unions. Gay rights advocates have called for benefits including housing privileges, access to base recreational facilities and joint duty assignments for couples in the military. Legal experts say, however, that the Pentagon will be unable to extend more than 100 benefits while the Defense of Marriage Act remains in place.


#### First Time Overseas For MacDill AFB's **VIP Transport Unit**



One of the C-37A executive jets assigned to the 310th Airlift Squadron, at MacDill AFB, Fla., along with 11 of the unit's airmen plus contractor support staff, deployed to Afghanistan, marking the squadron's first-ever overseas stint, said base officials. # Disability Claims Initiative Reduces Processing Times, Adds Convenience



The Department of Veterans Affairs has launched a new initiative that could eliminate the requirement for an in-person medical examination for some Veterans and shorten the time it takes to process Veteran's disability compensation claims. The initiative is called Acceptable Clinical Evidence (ACE). This initiative was developed by both the Veterans Health Administration (VHA) and the Veterans Benefits Administration (VBA) in a joint effort to provide a Veteran-centric approach for disability exams. Use of the ACE process opens the possibility of doing assessments without an inperson examination when there is sufficient information in the record. Under ACE practices, a VA medical provider completes a Disability Benefits Questionnaire (DBQ) by reviewing existing medical evidence. This evidence can be supplemented with information obtained during a need for some Veterans to report for an in-person examination. "ACE is a process improvement that will help us meet our goal to eliminate the claims backlog and provide more timely benefits to our Veterans, their families and survivors," said Undersecretary for Benefits Allison A. Hickey.

"The initiative also saves Veterans the inconvenience and costs associated with attending a medical examination." When a VA medical provider determines VA records already contain sufficient medical information to provide the needed documentation for disability rating purposes, the requirement for Veterans to travel to a medical facility for an examination may be eliminated. If VA can complete a DBQ by reviewing medical records already on file, it will use the ACE process. This would then expedite the determination of disability ratings in turn eliminating the wait time to schedule and conduct an exam from the claims process. During a 15month pilot test at one VA regional claims processing office, 38 percent of claims submitted were eligible for ACE. The ACE initiative is a part of the VBA's agency-wide Transformation Plan a five-year, multifaceted organizational change that is based on more than 40 personnel, process and technology initiatives designed to improve claims processing. The goal of the Transformation Plan is to eliminate the claims backlog and process all claims within 125 days with 98 percent accuracy in 2015. #### **Retirees' ID Cards Have Expiration Dates**

Military/Veteran/Political



Blue retiree identification cards issued prior to December 2012 had the word "INDEF" instead of an expiration date. Since December, retiree cards issued have an expiration date effective the day before the retiree's 65th birthday.

Although benefits will not automatically expire, some changes will take effect based on Medicare eligibility, Air Force Personnel Center officials said. "Retirees and their eligible spouses will still have access to benefits and they'll still be enrolled in the Defense Enrollment Eligibility Reporting System (DEERS), but the expiration date "which is one day before their 65th birthday" is a reminder to retirees that they must enroll in Medicare Part A and B to retain their TRICARE for Life eligibility," said Ed Yoder, of the Air Force DEERS project office.

Airmen who retired before the December card change took effect do not need to get a new ID card just because of the expiration date change, Yoder said. "If your ID card is worn out, unserviceable or your appearance has changed significantly enough that the picture is no longer a good likeness, you should get your card replaced. But there is no mandate to replace your card with the new expiration date card."

Retirees who have the new card showing the expiration date will get a replacement card showing the indefinite status once they turn 65, and spouses' cards will read "INDEF" once they turn 75, Yoder said.

Airmen who need or want to renew their retiree ID card can go to the nearest Real-time Automated Personnel Identification System office (military personnel section), or call their nearest RAPIDS facility for assistance and guidance.

Ronald Reagan's Childhood Home To Become Parking Lot For Obama's Library



The University of Chicago Medical Center has announced plans to turn Ronald Reagan's childhood home in Chicago into a parking lot for President Barack Obama's library.

The Commission on Chicago Landmarks previously denied the Gipper's home landmark status in 2012, according to **The Washington Times**, and the university subsequently scheduled demolition to begin in January. Officials claim the home does not reach landmark status because it is not architecturally significant and the nation's 40th president did nothing notable while living there.

With the wrecking balls in place, it could be just a few days before the home is knocked down. In its place, a plaque would serve as the marker of the historic spot, according to university representatives.

Reagan was 4 when his family moved to the 832 E. 57th St. in the Hyde Park District of the Windy City.

#### Cause Of F-35B Fuel Issue Identified



Investigators determined that an "improperly crimped" fuel hydraulic line was the cause of the anomaly with a Marine Corps F-35B strike fighter prior to take-off at Eglin AFB, Fla., on Jan. 16, F-35 program office spokesman Joe DellaVedova said.

The incident led to the grounding of the 25 F-35Bs in use as test and training assets across the country. The stand-down is still in place, said DellaVedova.

F-35 engine supplier Pratt & Whitney and the subcontractor for the fuel hydraulic line have instituted corrective action to improve their "quality control process and ensure part integrity," he said yesterday.

Investigators ruled out any design issues with the airplane, but did find six non-compliant parts that maintainers have removed and returned to P&W for replacement, he said. F-35 officials are working on the return-to-flight plan for the F-35Bs, he said. It will require removal and inspection of parts on the 25 airplanes, noted DellaVedova, adding that there was no specific date set yet for their return to flight operations.

F-35A and F-35C models have continued to fly during this time.

MacAidan "Mac" Gallegos was only 5 when his Afghanistan in 2009. Not a day goes by that he doesn't think about him.

"Curts will forever hold a special place in my decommissioning orders. "If my ship could speak today she would utter the words that now capture my thoughts; 'I suppose I must go, but I wish I could stay.'"

Curts was transferred to the inactive reserve on Feb. 27.



#### **Drone Use List Grows**



In response to a Freedom of Information (FOIA) request by the Electronic Frontier Foundation, the FAA has released an updated list of public agencies that have applied for permission from the FAA to operate unmanned aerial systems (UAS).

There are now at least 81 agencies that want to fly drones. Most are universities or other research-oriented institutions, and law-enforcement agencies make up the next largest group.

Under current FAA rules, drones of all sizes can only be legally operated for non-hobby use through special authorization by the FAA. The list does not indicate which applications have been approved or rejected.



#### Sleepy, Sloppy, But Good

The Air Mobility Command cited pilot error as the cause of the surprise landing of a C-17 at a small airstrip four miles shy of its intended touchdown at MacDill AFB, Fla., last July.

"The young pilot did a good job landing, albeit on the wrong strip," said U.S. Central Command boss Marine Corps Gen. James Mattis, who was one of the 23 passengers aboard the July 20 flight.

AMC officials said the pilot misjudged his position due to "fatigue, complacency, and a lack of flight discipline," states the report.

The Peter O. Knight Executive Airport is on Davis Islands, across Hillsborough Bay from MacDill AFB. Its runway roughly aligns on the same heading as MacDill's. The air crew managed to land the C-17 safely, causing minimal damage to the executive airport's runway.

MacDill officials are modifying the way they handle incoming air traffic to mitigate the chances of pilots confusing the two airfields.

#### **USS Cole Returns From Maiden Missile Defense Deployment**



The guided-missile destroyer USS Cole (DDG 67) returned to Naval Station Norfolk, VA, on January 6<sup>th</sup>, marking the successful conclusion of her maiden ballistic missile defense deployment to the Mediterranean Sea.

#### The KC-46A's Nuclear Support Mission

When the U.S. Air Force's KC-46A tankers enter the fleet, they will be equipped with electromagnetic pulse protection that will allow their electronics to survive a nuclear blast, a service official has said.

The KC-46s, which will replace the service's oldest KC-135 tankers, will be tasked with "nuclear operations support" as one of their primary missions, states the Fiscal 2012 report to Congress from the Pentagon's director of test and evaluation. (The others are: global strike, air bridge support, aircraft deployment, theater support, and special operations support, according to the report.)

KC-46s will have another nuclear-related mission as a secondary responsibility: air sampling, Air Force spokesman Ed Gulick said on Jan. 25. This entails "equipment to collect air samples downwind from areas where nuclear explosions have occurred," said Gulick in a written response to questions. This ancillary role will support the U.S. Atomic Energy Detection System, he said. It is a global network of monitoring for nuclear events.

#### **VA/DOD Continue To Improve Online** Access To Benefits Information



and Veterans benefits resources. "eBenefits is clearly becoming the platform of choice for Veterans seeking access to the numerous benefits they have earned," said VA's Undersecretary for Benefits, Allison A. Hickey. "The increasing capabilities of eBenefits give Veterans and service members greater flexibility in securing the information they are looking for."

The latest release, eBenefits 4.3, allows for easy navigation of the online disability compensation claim submission process using interview-style questions and drop-down menus similar to taxpreparation software, instead of a traditional fill-inthe-blank form. The latest release also pre-populates the application with information from a Veteran's record in VA's secure database. Veterans can view processing times for each phase of their claim.

Other site improvements include a tool to help determine if a Veteran has eligibility for Vocational Rehabilitation and Employment benefits, a calculator for military reservists to determine retirement benefits, and a search function that identifies a claimant's appointed Veterans service representative, with links to Google Maps indicating the location of their nearest representative's office. Military and Veterans can also access records like Post-9/11 GI Bill enrollment status, VA payment history, and DOD TRICARE health insurance status.

The eBenefits application is a key component of VA's ongoing trans-formation to a digital environment for Veteran's benefits delivery and fully supports VA's Veterans Relationship Management initiative that provides Veterans with the ability to access information about their benefits anywhere, anytime, and empowers them to manage those benefits through self-service capabilities. Additional functionality and features will continue to be added to the site throughout the coming months.

To access eBenefits, Veterans and Military must obtain a DoD Self-Service Logon (DS Logon), which provides access to several Veterans and military benefits resources using a single username and password. The service is free and may be obtained in person at a VA Regional Office, DOD ID Card station or online at www.ebenefits.va.gov.

#### About Gun Control... From Experts!

Politicians, pundits and private citizens have been sounding off on Barack Obama's new push for gun bans, but what do the professionals whose job it is to use guns in the protection of their nation, their fellow countrymen and themselves say?

An open letter has been posted on the Soldiers blog that has been signed as of this writing by more than 1,800 current and former U.S. Army Special Forces soldiers, the Green Berets. The soldiers say first it's important to define the issue and set the record straight. "The terms 'assault weapon' and 'assault rifle' are often confused." According to Bruce H. Kobayashi and Joseph E. Olson, writing in the Stanford Law and Policy Review, 'Prior to 1989, the term 'assault weapon' did not exist in the lexicon of firearms. It is a political term, developed by anti-gun publicists to expand the category of assaults rifles.' Green Berets, who use the weapons, point out the M4A1 carbine is a U.S. military service rifle - it is an assault rifle."

"The AR-15 is not an assault rifle. The 'AR' does not stand for 'Assault Rifle', it's the first two letters of the ARmaLite Corp. The AR-15 is designed so it looks like the M4A1, but it cannot be configure to be a fully automatic rifle. It is a single shot semiautomatic rifle that can fire 45-60 RPM depending on the skill of the shooter. The M4A1 can fire up to 950 RPM. In 1986, the govt banned ALL new automatic firearms for civilians. Therefore, the sale of assault rifles are already banned or heavily restricted!"

Likewise, a ban on "high-capacity" magazines would be irrelevant, case in point is Eric Harris at Columbine HS as proof. The first weapons ban was adopted in 1994, and one of those bans was to have a maximum ten-round magazines. In 1999, five years into the Federal Assault Weapons Ban, the Columbine HS massacre occurred. Harris, had a rifle with only a ten-round capacity, he simply had more of them: thirteen magazines in total. Harris fired 96 rounds before killing himself."

And, underlying the issue is the Constitution's assurance of protection for the "sacrosanct" right of self-defense. "Our Constitution established a system of governance that preserves, protects, and holds sacrosanct the individual rights and primacy of the governed as well as providing for the explicit protection of the governed from governmental tyranny and/or oppression." It is easy to blame guns, but weapons aren't really the problem. Civilized society already proves it, they cite the experience in Great Britain.

In 1987 was the Hungerford massacre that killed 18, and the government followed with a 1988 law banning semi-automatic guns. But eight years later, a "disturbed" man murdered 16 children and a teacher at the Dunblane school. Immediately the law was amended to ban "all private ownership of handguns." Somehow, criminals didn't get the memo.

"Despite having the toughest gun control laws in the world, gun crimes increased in 2003 by 35% over the previous year with firearms used in 9,974 recorded crimes. Gun related homicides were up 32% over the same period. Gun related crime had increased 65% since the Dunblane massacre and implementation of the toughest gun control laws in the developed world,"

"In contrast, in the USA in 2009 (5 years after the Federal Assault Weapons Ban expired) total firearm related homicides in the U.S. declined by 9% from the 2005 high," the letter says, citing FBI statistics. Since gun bans don't really impact violence, what is the issue at hand?

"The purpose of the Second Amendment is to secure our ability to oppose enemies foreign and domestic, a guarantee against disorder and tyranny." Throughout history, disarming the populace has always preceded tyrants' accession of power. Hitler, Stalin, and Mao all disarmed their citizens prior to installing their murderous regimes.

At the beginning of our own nation's revolution, one of the first moves made by the British was an attempt to disarm our citizens. When our Founding Fathers ensured that the Second Amendment was made a part of our Constitution, they were not just wasting ink. They were acting to ensure our present security was never forcibly endangered by tyrants, foreign or domestic.

But school shootings are horrible and need to be addressed. "First, it is important that we recognize that this is not a gun control problem; it is a complex sociological problem. No single course of action will solve the problem." These military Veterans say local schools should make their own decisions and plans.

We have a responsibility to stand by our principles and act in accordance with them. Our children are watching and they will follow the example we set."

#### **U.S. Sailors Cautioned After Legalization** Of Marijuana

Although the state of Washington has recently updated the law on the use of marijuana, essentially decriminalizing its use for civilians, Zero Tolerance drug policy regulations remain unaffected for sailors.

The Zero Tolerance drug policy was implemented after a fatal crash of an EA-6B Prowler on board USS Nimitz in 1981, killing 14 crew members and injuring 45 others. Autopsies were performed and several members of the flight deck crew tested positive for marijuana. Following this discovery, then-President Ronald Reagan instituted a Zero Tolerance drug policy across all of the U.S. armed forces. As a result, regular, random urinalysis drug checks are conducted on all military personnel.

"Marijuana can stay in the system for up to 30 days depending on the person's metabolism, dosage and method of consumption," said Hospital Corpsman 3rd Class David Johnson. "Because it's lipid-based, it can stay in the fat cells for a long period of time, whereas water-based substances would flow through very quickly."



#### Command Reduction of Army Personnel C.R.A.P.

As a result of DOD budget cutbacks, we are forced to reduce the size of the force. Under CRAP, older soldiers will go on early retirement, thus permitting the retention of lower paid soldiers who represent the Army's future.

A program to phase out older soldiers via retirement by the end of the current fiscal year will be placed in effect. The program will be known as Retire Active Personnel Early (RAPE).

Soldiers who are RAPEd will be given the opportunity Always read stuff that will make you look good if you die to seek civilian employment within the Department of the Army. To that end, RAPEd soldiers will be required to fill out numerous DA Forms (currently in the development, test, and evaluation stage) detailing their education and experience. This phase does not guarantee retired soldiers a soldier's unique capabilities will be considered before being bypassed in the hiring process. This phase of CRAP is It may be that your sole purpose in life is simply to serve known as Survey of Capabilities of Retired Warriors (SCREW).

> Soldiers who have been RAPEd and SCREWed may request review of their situation by higher authority. This is the Study by Higher Authority Following Termination (SHAFT) phase.

> CRAP policy dictates that a soldier may be RAPEd once, SCREWed twice, but may be SHAFTed as many times as the Army leadership deems appropriate.

> If a soldier follows the above procedures, he or she will be entitled to get Half Earnings for Retired Personnel Early Severance (HERPES). As HERPES is considered a benefit payment, any soldier who gets HERPES will no longer be RAPEd or SCREWed by the Army.

The Army leadership wishes to assure younger soldiers who remain on active duty that the Army will continue its policy of ensuring that soldiers are well trained through our Special High Intensity Training (S.H.I.T.) program. The Army takes pride in the amount of SH\*T our soldiers receive and can boast that it gives its soldiers more SH\*T than any other service.

#### U.S. State Dept. Recruiting jihadists For The Foreign Service, Web Site Says



"In what can only be described as a mindboggling policy move, the State Department recruited Muslim participants at a conference sponsored by groups with ties to radical Islamists to become members of its foreign service, the web site **Godfather Politics** says.

Foreign Service officers represent the United States at its embassies and consulates around the globe. The recruitment drive is part of the Obama administration's larger Muslim outreach policy, the web site says.

Mark Ward, the Deputy Special Coordinator in the Office of Middle East Transition, gave a 90minute seminar on career opportunities for Muslim youths during a recent conference held in Chicago by the Muslim American Society and the Islamic Circle of North America. Other speakers at the conference included a fundraiser for the Holy Land Foundation convicted of funneling millions of dollars to Hamas, and a founder of the MAS who praised Palestinian terrorists in a presentation on jihad and "martyrdom." Joining Ward in presenting the jobs seminar was a man named Oussama Jammal, president of the Mosque Foundation, which raised hundreds of thousands of dollars for the Holy Land Foundation.

As part of its Muslim outreach efforts, the State Department has also reportedly been meeting in secret with Islamist groups, has sent a known anti-American cleric on a Mideast outreach tour, and has dumbed down federal anti-terrorism training to eliminate "negative references" to Muslims. Hillary Clinton even used her authority to allow two banned Islamic scholars to enter the United States, according to the web site.

Much has been written, outside the mainstream media, about the infiltration of the Obama administration by the Muslim Brotherhood, particularly at the State Department, where Clinton's top aide had undisputed family ties to the Muslim Brotherhood.

**Germany Air Base Losing Its Warthogs** 



A-10 from the 81st Fighter Sqdn, Spangdahlem AB, Germany. The inactivation of the 81st Fighter Squadron, at Spangdahlem AB, Germany, will proceed this year, affecting about 500 personnel who operate and maintain the unit's A-10 ground-attack airplanes, announced base officials.

This move is part of the Air Force force structure changes in Fiscal 2013. While Air Force officials announced nearly one year ago the service's desire to stand down the 81st FS, they had to wait on the completion of the Fiscal 2013 defense authorization legislation to know what changes they could make across the force in the fiscal year.

President Obama signed the legislation into law in early January.

Service officials have yet to finalize the specific plans to relocate the squadron's A-10s, states the base's Jan. 31 release. However, the squadron is currently moving some aircraft to Moody AFB, Ga., and Davis-Monthan AFB, Ariz., to support training requirements and to augment A-10 units at those locations. The squadron's remaining aircraft and personnel will withdraw from Spangdahlem by the year's end, states the release.

Author Of 'American Sniper' Shot And Killed At Gun Range



Chris Kyle, an ex-U.S. Navy SEAL who wrote the best-selling book American Sniper about his service in Iraq, was shot and killed at a gun range in Texas, multiple outlets reported. A second man was also killed.

According to local TV station KHOU, officials said that Kyle was shot at point-blank range "while helping another soldier who was recovering from post traumatic stress syndrome" at a range near the town of Glen Rose.

The Dallas Morning News reports that Lancaster, Texas, police arrested a suspect, 25-yearold Eddie Ray Routh, after a brief chase.



# DHS Training TSA Agents To Save Themselves During Shootings

# **Air Force Reserve Announces Revised Force Structure Actions**



U.S. Air Force Reserve Command officials are moving forward with force structure changes authorized by the National Defense Authorization Act for fiscal 2013.

Air Force, Air Force Reserve and Air National Guard leaders collaborated to develop one Total Force proposal in response to concerns raised by state governors and Congress regarding the FY-13 president's dudget submission and subsequent congressional marks that placed proposed force structure actions on hold.

As enacted into law, the NDAA included the entire "amended" Air Force Total Force proposal as well as the retention of additional intra-theater airlift aircraft, retention of the Global Hawk Block 30s and a delay of the retirement of 26 C-5A Galaxies until 45 days after delivery of a new Mobility Requirements and Capabilities Study. It also directed a National Commission on the Structure of the Air Force and limited retirement of B-1 Lancers.

"In a difficult economy, the Air Force has to make tough choices," said Maj. Gen. Craig Gourley, the AFRC's vice commander. "These force structure changes will take place over the next three years and are necessary to help meet Budget Control Act of 2011 resource levels."

- The 655th Intelligence, Surveillance and

   The 960th Cyber Operations Group, at Joint Base San
- Antonio-Lackland, Texas, and;
- The 960th Network Warfare Squadron, a classic associate unit at Joint Base San Antonio-Lacklad, Texas.

Other force structure actions authorized by the act include:

- Barksdale AFB, La., Inactivate the 917th Fighter Group and retire 24 A-10C Thunderbolt IIs and transfer three A-10Cs to Whiteman AFB, Mo.
- Beale AFB, Calif., Inactivate the 13th Reconnaissance Squadron.
- Davis-Monthan AFB, Ariz., Gain 24 A-10Cs from the Air Force in 2014.
- Lackland AFB, Teexas, Retire 16 C-5As during the next three years and gain 8 C-5Ms from Westover Air Reserve Base, Mass., in 2016 (C-5 retirements are delayed until 45 days after delivery of a new Mobility Requirements and Capabilities Study).
- Westover ARB, Mass., Transfer eight C-5Ms to Lackland in 2016.
- Tinker AFB, Okla., Retire four KC-135 Stratotankers.Whiteman AFB, Mo., Gain three A-10Cs from
- Whiteman AFB, Mo., Gain three A-10Cs from Barksdale AFB, La.
   Robins AFB, Ga., Inactivate the Band of the U.S. Air
- Force Reserve.

- March ARB, Calif., Retire one KC-135 in 2013. The Air Force has convened an intra-theater airlift working group and is using a deliberate approach to develop courses of action to determine the placement of additional intra-theater airlift assets. Additional changes to Air Force Reserve C-130 units will be made based upon decisions made by the working group.

# Obama Asks Military Leaders If They'll Fire On U.S. Citizens



2009 Nobel Peace Prize nominee Jim Garrow shockingly claims he was told by a top military Veteran that the Obama administration's "litmus test" for new military leaders is whether or not they will obey an order to fire on U.S. citizens.

Garrow was nominated three years ago for the prestigious Nobel Peace Prize and is the founder of The Pink Pagoda Girls, an organization dedicated to rescuing baby girls from gendercide in China. Garrow has been personally involved in "helping rescue more than 36,000 Chinese baby girls from death."

He is a public figure, not an anonymous voice on the Internet, which makes his claim all the more disturbing. "I have just been informed by a former senior military leader that Obama is using a new "litmus test" in determining who will stay and who must go in his military leaders. Get ready to explode folks. "The new litmus test of leadership in the military is if they will fire on U.S. citizens or not. Those who will not are being removed," Garrow wrote on his Facebook page, later following up the post by adding the man who told him is, "one of America's foremost military heroes," whose goal in divulging the information was to "sound the alarm." Garrow's claim is even more explosive given that the country is in the throes of a national debate about gun control, with gun rights advocates keen to insist that the founders put the second amendment in the Constitution primarily as a defense against government tyranny. It also follows reports on Sunday that General James Mattis, head of the U.S. Central Command, "is being told to vacate his office several months earlier than planned."

Concerns over U.S. troops being given orders to fire on American citizens in the event of mass gun confiscation first arose in 1995 when hundreds of Marines at 29 Palms, Calif., were given a survey as part of an academic project by U.S. Navy Lt. Cmdr. Ernest Guy Cunningham, which asked the Marines if they would, "Fire upon U.S. citizens who refuse or resist confiscation of firearms banned by the United States Govt." The survey was subsequently leaked because many of the Marines who took the survey was biased in acted properly

The U.S. Military has clearly outlined innumerable civil emergency scenarios under which troops would be authorized to fire on U.S. citizens. In July 2012, the process by which this could take place was made clear in a leaked U.S. Army Military Police training manual, Civil Disturbance Operations, dating from 2006.

Similar plans were also outlined in an updated manual released in 2010 entitled FM 3-39.40, **Internment and Resettlement Operations**.

The 2006 document outlines how military assets will be used to "help local and state authorities to restore and maintain law and order" in the event of mass riots, civil unrest or a declaration of martial law. On page 20 of the manual, rules regarding the use of "deadly force" in confronting dissidents on American soil are made disturbingly clear with the directive that "a warning shot will not be fired."

Given that second amendment advocates are now being depicted as dangerous terrorists by the federal government and local law enforcement, Garrow's claim is sure to stoke controversy given that Americans are seeing their gun rights eviscerated while the federal government itself stockpiles billions of bullets.

Last week, Gloversville Mayor Dayton King warned that any federal gun confiscation program could lead to a "Waco-style stand-off" in rural areas of America.

#### Obama Dealt Blow By Federal Court



Obama violated the Constitution when he bypassed the Senate last year to appoint three members of the National Labor Relations Board, a federal appeals court ruled Jan 25, in a far-reaching decision that could severely limit a chief executive's powers to make recess appointments.

The decision of the U.S. Court of Appeals for the D.C. Circuit marked a victory for Republicans and business groups critical of the labor board. If it stands, it could invalidate hundreds of board decisions over the past year, including some that make it easier for unions to organize.

When Obama filled the vacancies on Jan. 4, 2012, Congress was on an extended holiday break. But GOP lawmakers gaveled in for a few minutes every three days just to prevent Obama from making recess appointments. The White House argued that the pro forma sessions "some lasting less than a minute" were a sham. The court rejected that argument, but went even further, finding that under the Constitution, a recess occurs only during the breaks between formal year-long sessions of Congress, not just any informal break when lawmakers leave town.

White House Press Secretary said the administration strongly disagrees with the decision and that the labor board would continue to conduct business as usual, despite calls by some for the board members to resign. Under the court's decision, those recess appointments made by the president would be invalid. And those quarter million dollar salaries should be returned.

The White House hinted that they would ask the Supreme Court to overturn the decision, which was rendered by three judges. "We disagree with the court's ruling and believe that the appointments are sound."

"I think this is a very important decision about the separation of powers," said Carl Tobias, a constitutional law professor at Virginia's University of Richmond. The court's reading has limited the president's ability to counter the obstruction of appointments by the Senate that has disagreed with the Obama administration.

The ruling also threw into question the legitimacy of Obama's recess appointment of Richard Cordray to head the Consumer Financial Protection Bureau.

The case challenging the recess appointments was brought by Noel Canning, a Washington state bottling company that claimed an NLRB decision against it was not valid because the board members were not properly appointed. The D.C. Circuit panel agreed


Obama made the appointments after the Senate blocked his choices for an agency they contended was biased in favor of unions. Obama claims he acted properly because the Senate was away on a 20-day recess. But during that time, the Senate technically had stayed in session because it was gaveled in and out every few days for so-called pro forma sessions. Lawmakers used the tactic specifically to prevent the president from using his recess power to install members to the board. Democrats had also vigorously opposed the nomination of Cordray. Obama disagreed with the Senate and now the Court, he ignores the constitution when he sees fit.

The three-judge panel flatly rejected arguments from the Justice Department's Office of Legal Counsel, which claimed that the president has discretion to decide when the Senate is unavailable. "Allowing the president to define the scope of his own appointment power would eviscerate the Constitution's separation of powers," Chief Judge David Sentelle wrote in the 46-page ruling.

"With this ruling, the D.C. Circuit has soundly rejected the Obama administration's flimsy interpretation of the law, and it will go a long way toward restoring the constitutional separation of powers," said Sen. Orrin Hatch, R-Utah.

Rep. Candice Miller (Mich.) released the following statement after the Court of Appeals for the D.C. Circuit found that Obama violated his appointment power established in the Constitution by making recess appointments to these Boards when the Senate was not actually in recess. "The Court of Appeals for the D.C. Circuit sent a strong message that the president is not above the ultimate law of our land, the Constitution. Chief Judge David Sentelle said it very succinctly in the unanimous ruling, ~Allowing the President to define the scope of his own appointment power would eviscerate the Constitution's separation of powers." Our Founding Fathers when drafting our Constitution required the president to secure the advice and consent of the Senate for certain appointments to the government for very important reasons; foremost among them to prevent the abuse of power by any president.

"This abusive over-reach by Obama has now thrown the important work of the board into uncertain territory. Obama must respect the limits on his power enshrined in the Constitution and work appropriately with the Congress on all matters required by the Constitution to conduct the business of our nation."
