Industrial Hemp Bill Passes In Kentucky's Senate

Industrial hemp's growth from the fringes to the political mainstream in Kentucky continued on Thursday, with state Senate's passage of a bill to strictly regulate the crop if the federal government lifts its current ban on the one-time agricultural staple in the Bluegrass State.

The bill, which would license hemp growers if the crop gains a federal reprieve, cleared the Senate on a 31-6 vote as supporters promoted its potential to diversify Kentucky farms in an era when tobacco's influence has waned. They said hemp's comeback would create processing and manufacturing jobs in converting the plant into products that include paper, clothing, auto parts, bio-fuels, food and lotions.

Sen. Paul Hornback, a tobacco farmer and the bill's lead sponsor, said Kentucky needs to be at the forefront of giving the versatile crop a chance if the federal ban is lifted. The Shelbyville Republican said he had heard recently from two companies interested in capitalizing on a hemp comeback in Kentucky, including a processing company in Canada looking to "Give us the opportunity," Hornback said. "Put us in options by sponsor status, and much more. More at: a position in Kentucky to give us an opportunity to see how this works. MORE GUNS LEAVING LIBERAL STATES By Michelle Malkin

Obama used his State of the Union address to crusade for a revitalized U.S. manufacturing sector. But while he pays lip service to supporting businesses that build their products on American soil, driving a key sector of the U.S. manufacturing industry six feet under: the American firearms and ammunition industry.

The company's innovations in weaponry and ammunition have been used in sporting, self-defense, law enforcement and warfare for two centuries. Now, as a result of hysteria-induced government pandering, nearly 40 percent of Remington's weapons can no longer be sold to citizens legally. Its small-town plant employs more than 1,300 people in a town of 8,000 and sales in the U.S. and 55 other countries. As an Ilion local official noted, "Remington is not only a major of our very fiber for 200 years."

Feds Admit Gun Laws Won't Slow Crime By Garth Kant, WorldNetDaily

A study by the Department of Justiceâ€[™]s research wing, the National Institute of Justice, has the feds admitting that so-called "assault weapons" are not a major contributor to gun crime.

The study also concluded those weapons are not a major factor in deaths caused by firearms, nor would an "assault weapons" ban be effective.

"The existing stock of assault weapons is large, undercutting the effectiveness of bans with it said. "Therefore a complete exemptions," elimination of assault weapons would not have a large impact on gun homicides." The report finds no significant link between "assault weapons" and murders. "Since assault weapons are not a major contributor to U.S. gun homicides and the existing stock of guns is large, an assault weapons ban is unlikely to have an impact on gun violence," the report said.

The document, titled, Summary of Select Firearm Violence Prevention Strategies, also sees no epidemic of mass shootings. "Fatalities from mass shootings (those with 4 or more victims in a particular place and time) account on average for 35 fatalities per year," the report said.

Veterans Get Letters From VA Prohibiting **Possession Of Weapons And Ammunition** By Michael Connelly, J.D.

How would you feel if you received a letter from the govt informing you that because of a physical or mental condition that the govt says you have it is proposing to rule that you are incompetent to handle your own financial affairs? Suppose that letter also stated that the govt is going to appoint a stranger to handle your affairs for you at your expense? That would certainly be scary enough, but it gets worse.

What if that letter also stated: A determination of incompetency will prohibit you from purchasing, possessing, receiving, or transporting a firearm or ammunition. If you knowingly violate any of these prohibitions, you may be fined, imprisoned, or both pursuant to the Brady Handgun Violence Prevention Act, Public Law 103-159, as implemented at 18 United States Code 924(a)(2)."

That makes is sound like something right from a documentary on a tyrannical dictatorship somewhere in the world. Yet, as I write this I have a copy of such a letter right in front of me. It is being sent by the U.S. Department of Veterans Affairs to hundreds, perhaps thousands, of America's heroes. In my capacity as Executive Director of the United States Justice Foundation (USJF) I have been contacted by some of these Veterans and the stories I am getting are appalling.

The letter provides no specifics on the reasons for

Expeditionary A-10 Unit Racks Up 10,000 Al Jazeera Makes Major U.S. Expansion Combat Flight Hours



A-10s deployed from Davis-Monthan AFB, Ariz., to Bagram Airfield, Afghanistan, have amassed 10,000 combat flight hours since arriving in theater last fall, according to a Bagram release. These A-10s, operating as the 354th Expeditionary Fighter Squadron, reached the milestone during a Feb. 12 sortie flown by Brig. Gen. Joseph Guastella, commander of Bagram's 455th Air Expeditionary Wing, according to the Feb. 13 release. The Davis-Monthan A-10s touched down at Bagram last October as part of a regular rotation of combat forces. The expeditionary squadron has seen extensive combat in Afghanistan during Operation Enduring Freedom, operating both at Bagram and at Kandahar Airfield over the years.

South Korea Suicide-Free For Troops



Even as the U.S. Army recorded its worst year in decades for soldiers killing themselves - with 323 deaths in 2012 - there were places in the service where suicides are rare. One is South Korea.



Seven years after it arrived in the U.S., Al Jazeera is putting up its sign. As it launches a major expansion to become a full-fledged cable news channel in the U.S., the Middle East-owned network believes animosity toward its sister Arabic-language news operation has waned. Or at least it has dissipated enough to allow Al Jazeera to splash its name across its new Washington broadcast center, which is currently housed in a dingy, unmarked office building.

"Imagine six or seven years ago, trying to find real estate for Al Jazeera in Washington. I'm sure it wasn't easy," says Bob Wheelock, the former ABC executive in charge of setting up Al Jazeera America, as the network will be called. But now "We're going to have signage, you know, just like CBS, ABC, CNN, CBN, just like everybody else," he says. "We're psyched."

With the \$500 million purchase of **Current TV** from former U.S. vice president Al Gore and other investors last year, **Al Jazeera** bought a place on cable boxes in 41 million homes. Now the network plans to grow from a news operation of 13 people to 200 people working in cities across the country. To do so, the network recently posted job listings for more than 100 reporters, producers, videographers and the like. It received 13,000 applications. The network has deep pockets: It is owned by the government of Qatar.

Suggestions that the network goes easy on Arabs and hard on Israel is refuted, they say they are straight shooters as much as any major news outlet. There is no unbiased news, says Isobel Coleman, of the Council on Foreign Relations. "The bias is in the selection of what stories you cover and how you cover them. **Al Jazeera** will bring its own bias, but it's no more or no less than what we're used to in this American country."

Burglar Shot By St. Louis Resident

Police say the teen who was fatally shot by a resident in a backyard on Tennessee Avenue was killed while trying to burglarize the man's home.

The shooting happened at 1:24 a.m., local time, today in the 3700 block of Tennessee Avenue, just south of Gravois Park. The dead teen was identified as Demetrius Murphy, 15, of the 4600 block of Louisana Avenue.

Police say Murphy was with a 17-year-old male. They were "forcibly attempting to burglarize the victims' home," police said in a brief summary of the incident. At the home were two people: a 33-year-old man and a 28-year-old woman. The man went outside "to investigate the activity," police say, and shot Murphy as Murphy approached him.

Police did not identify the man who fired the gun, but said his actions appeared to be justified. Under Missouri's castle doctrine, people who encounter an intruder in their homes or vehicles - or their property, under a more recent expansion of the law - can use deadly force without fear of being charged or sued.

Police said detectives will be applying for warrants for felony murder against the dead teen's accomplice. Missouri law allows him to be charged because someone died in the commission of a burglary. That teen's name has not been released.

UN Un-Human Rights Council

Voted in December as vice-presidents of the United Nations Human Rights Council for 2013 were the nations of Mauritania and Maldives, both of which permit the death penalty for renouncing Islam.

In Mauritania, a person so charged has three days to repent for a lesser sentence. An August 2012 dispatch in London's **The Guardian** reported widespread acceptance of slavery conditions in Mauritania affecting as many as 800,000 of the 3.5 million population. Said one abolitionist leader, "Today we have the slavery that American plantation owners dreamed of in that the slaves believe their condition is necessary to get to paradise."

All F-35s have been grounded as a precaution after a routine engine inspection revealed a crack on an engine blade, Defense Department officials said yesterday. Officials call this a "cautionary suspension of flight."

The Air Force, Navy and Marine Corps fly F-35s. Inspectors found the crack in an F135 engine installed in an F-35A Lightning II at Edwards Air Force Base, Calif. This is the conventional take-off and landing version of the joint strike fighter. Officials are shipping the engine and its associated hardware to Pratt & Whitney's engine facility in Middletown, Conn., to conduct more thorough evaluation and root cause analysis.

Former American diplomat Thomas Pickering said what struck him most during a review of last year's attacks on the U.S. Mission in Benghazi, Libya, were the frequent personnel changes, second-guessing on security upgrades, and dismissive attitude toward dozens of security incidents. U.S. House Says \$1 Billion Wasted On Veterans' Medical E-Records



The departments of Defense and Veterans Affairs have wasted about \$1 billion in a failed effort to streamline medical record-keeping, the chairman of the House Veterans' Affairs Committee said in a hearing yesterday.

"I'm concerned we're taking a step back toward a model that has been tried and failed," said committee Chairman Rep. Jeff Miller (R-Fla.), at a hearing to examine the project.

Defense and VA officials said this month they had abandoned an ambitious plan to integrate medical records for both active duty service members and Veterans into a single electronic system to make the records more accessible for patients and doctors. After cost estimates doubled and technology problems persisted, they decided on a less expensive plan to keep their current systems while making them "interoperable."

The project, which started in 2004, was meant to streamline health care for active duty troops and Veterans as they transition to civilian life. Officials hoped a centralized system would prevent delays in care caused by problems in sharing health records between separate systems. The plan was set to start in 2017 for a total cost of \$4 billion, according to Pentagon estimates from last year.

Committee members criticized the departments for giving up on a program that has already cost about \$1 billion. "It's inexcusable," said Rep. Jeff Denham (R-Calif.). "In the private sector this would be done by now - it would have to be."

A "patchwork of initiatives" tried over the past 15 years has left Veterans short-changed by an outdated system, said Valerie Melvin, director of information management and technology resources issues at the Government Accountability Office (GAO), Congress' investigative arm. Melvin authored a report released yesterday that questions the departments' ability to share health records with existing systems. "This is the result of poor oversight and inadequate accountability," Melvin testified. "The program has not been positioned to fulfill key management responsibilities. More is needed."

None of the testimony or reports "makes me think we won't be sitting here in another 10 years asking the same questions and having the same problems," said Rep. Phil Roe (R-Tenn.).

The new program will be working by the end of the year and save the government "hundreds of millions" of dollars, said Elizabeth McGrath, the Pentagon's deputy chief management officer. However, she could not provide specific cost figures.

Changes in the military health care system led the departments to decide against a unified system, VA Assistant Secretary for Information and Technology Roger Blake told the committee. "We needed to reorder our thinking about what an e-record is," he said.

American Student Punished For Not Reciting Mexican Pledge Of Allegiance By Todd Starnes

A Texas high school student has filed a federal lawsuit against her school and her teachers after she was punished for refusing to salute and recite the Mexican Pledge of Allegiance.

The Thomas More Law Center filed the suit on behalf of Brenda Brinsdon, alleging the McAllen Independent School District violated the 15-year-old girl's constitutional rights when she was forced to recite the Mexican pledge and sing the Mexican national anthem.

Brinsdon, who is the daughter of a Mexican immigrant and an American father, refused. She believed it was un-American to pledge a loyalty oath to another country.

Ironically, the school district has a policy that prohibits a school from compelling students to recite the American Pledge of Allegiance. The district also has a written policy that excuses students from reciting text from the Declaration of Independence if the student "as determined by the district, has a conscientious objection to the recitation."

"There is a sad trend in public schools across our nation to undermine American patriotism," said Richard Thompson, president of the Thomas More Law Center. "But it's encouraging to see students like Brenda stand up for America despite pressure from school officials."

What's most troubling is the different treatment for someone wanting to opt out of reciting the American Pledge of Allegiance compared to someone as a matter of conscience wants to opt out of reciting the Mexican pledge," spokesman Erin Mersino said.

The recitation of the Mexican pledge and the singing of the Mexican national anthem was part of a 2011 Spanish class assignment at the Achieve Early College High School. The teacher, Reyna Santos, required all her students to participate in the lesson. When Brinsdon refused to back down, she was punished, the lawsuit alleges. She was given an alternative assignment on the independence of Mexico. The teacher gave her a failing grade and then required the student to sit in class over a period of several days to listen to other students recite the Mexican pledge. The lawsuit states Brinsdon offered to recite the American pledge in Spanish but the teacher refused her request.

"It's astonishing that this Texas school would deny Brenda her right of conscience and free speech not to pledge allegiance to a foreign country," said Thompson. "Too many Americans" including those of Mexican descent "have suffered and died protecting our nation."

And while she is fluent in Spanish and English and is proud of her Mexican heritage, Brinsdon is a "true-blooded American," Mersino added.

But it also reflects the probability that the spending cuts will hurt the economy, which in turn will lower tax revenue and drive up the costs of social safety-net programs like unemployment insurance.

First operations P-8A squadron prepares for deployment

USN photo by Personnel Specialist 1st Class Anthony Petry I have served in our Navy for more than 30 years, the vast majority of that time as a naval flight officer flying P-3 Orions. My dad flew the P2V, and now my son is flying Orions. You could say flying is in my blood.

When I first started this journey, there were 24 active duty operational squadrons and more than 240 P-3s in the fleet. Today, the force consists of 12 active duty patrol squadrons with fewer than 85 of 132 P-3s available on flight lines in the fleet.

Last year, the Orion celebrated its 50th anniversary. To date, the average P-3 in the fleet today has logged more than 17,000 flight hours with one aircraft, No. 158919, aka 'Nine-inch Nails' flying more than 26,000 hours. These numbers significantly exceed the original design life of the aircraft, and substantial structural repairs to the wings have been required over the years to achieve this longevity.

Despite the success of these wing repairs, remaining P-3s continue to age. We are living on borrowed time with our P-3s.

Five years ago, in the midst of managing fatigue-life issues with our P-3 fleet, we developed a plan to transition the fleet to the P-8A Poseidon beginning in spring 2012. I'm pleased to report drones or other means, to attack or kill or maim, Air Station Jacksonville, Fla., in accordance with the plan we laid out.

"A lot of these people weren't even arrested in my county," he said. "A lot of them were arrested in Phoenix or somewhere else, and they're brought into my county - and now, they are released on the streets and in my neighborhoods. "It is unacceptable for anyone to believe that's feasible. These are people who have defied and disrespected our law to come into our country - and we've had a problem even stopping them from coming into our sovereign country - so how do they think we're going to be able to handle criminal illegals?" Babeau asked. "They don't respect the law."

And House Judiciary Committee Chairman Bob Goodlatte was just as brutal. "It's abhorrent that Obama is releasing criminals into our communities to promote his political agenda on sequestration," the Virginia Republican said. "By releasing criminal immigrants onto the streets, the administration is needlessly endangering American lives," he added.

Obama Stuns Israel With Palestine State

DOJ Memo Recommends Registration And Confiscation Of Guns

The memo is entitled, **Summary of Select Firearm Violence Prevention Strategies**, and is dated Jan. 4, 2013.

Obama has yet to publicly support national registration or firearms confiscation, although the memo reveals his administration is moving in that direction.

The memo stands in stark contrast to the administration's public stance on so-called gun control. White House spokesman Jay Carney said last month that laws proposed by Obama would not "take away a gun from a single law-abiding American."

Nintendo Medal Higher Than Purple Heart



The military has halted production of its new medal for drone- and cyber-warfare, ordering a review in response to complaints about what some have derisively dubbed the "Nintendo" medal.

A Pentagon spokesman confirmed that Defense Secretary Chuck Hagel has asked Joint Chiefs Chairman Gen. Martin Dempsey to lead a review and report back in 30 days in light of the controversy.

At issue is the newly created Distinguished Warfare Medal, which was to be awarded to troops who operate drones and use other technological skills to fight America's wars from afar -- most controversial was the fact that it has been ranked above medals for those who served on the front line in harm's way, such as the Purple Heart given to wounded troops.

Rep. Duncan Hunter, R-Calif., who has introduced a bill to lower the medal's ranking, said the award is "widely viewed as an award that undermines all other valor awards and the reverence for servicemembers who face the dangers of direct combat."

"It's a fact that those who are off the battlefield do not experience the same risks. Pretending they do devalues the courageous and selfless actions of others, who, during combat, do the unthinkable or show a willingness to sacrifice their own lives," he said in a statement.

Officials said in announcing the medal last month that it would be the first combat-related award to be created since the Bronze Star in 1944. And they said that in recognition of the evolving 21st century warfare, the medal would be considered a bit higher in ranking than the Bronze Star, but lower than the Silver Star.

The Veterans of Foreign War and other groups say that ranking it ahead of the Bronze Star and Purple Heart is an injustice to those who served on the frontlines.

John Bircher, a spokesman for the Military Order of the Purple Heart, has said the Veterans groups are not objecting to the medal -- just the ranking. He said some medals ranked ahead of the Purple Heart are achievement medals that can be earned outside of war time. What bothers many Veterans is that the new Distinguished Warfare Medal appears be a war-time medal that trumps acts of valor, which he finds insulting.



As part of its ongoing transformation from paper-based to electronic claims processing, the Department of Veterans Affairs has continued to improve the automated payment of benefits for veterans participating in the Post-9/11 GI Bill education program. As a result, VA is now providing benefit payments to currently enrolled students in an average of six days "cutting by more than half the processing time experienced during the spring enrollment period last year. This enhancement to VA's automated processing system, called the "Long Term Solution (LTS)," uses approximately 80 business rules to support end-to-end automation of Post-9/11 GI Bill claims, ensuring accurate payments without the need for manual handling. During the month of February, 46 percent of incoming documents (over 115,000) for enrolled students were fully automated, and an additional 33 percent were partially automated. For enrolled students starting a new semester of classes, processing is taking an average of six days to complete. For new students using the benefit for the first time, the average time to establish their eligibility under the Post-9/11 GI Bill is around 24 days. "We are happy to report that our newest technology has substantially reduced the amount of time it takes to process veterans' education claims," said Undersecretary for Benefits Allison A. Hickey. "It's a good example of the VBA's transformation that is delivering better service to the fast-growing number of Post 9/11 GI Bill participants." The rulesbased processing approach, LTS, uses is also being built into VA's technology for VA's paperless disability claims processing - the Veterans Benefits Management System (VBMS). Over the past three and 1/2 years, VA has provided \$27 billion in Post-9/11 GI Bill benefits to approximately 938,000 veterans, service members, and their families, and to the universities, colleges, and trade schools they attend. A homeless veteran says he was just looking for something to eat when he was ticketed by Houston police officers for rummaging through a trash can.

44-year-old James Kelly tells the Houston Chronicle he was cited for "disturbing the contents of a garbage can in downtown business district."

"I was just basically looking for something to eat," Kelly told the paper. "I wasn't in a real good mood."

Houston city officials pointed out in an e-mail to the paper that a charitable food event was happening at the same time Kelly was cited, but referred all other questions on the matter to police.

"The ordinance is specific to the Central Business District," the Houston Police Department said in a statement. "It is a violation for anyone to remove any contents of any bin, bag or other container that has been placed for collection of garbage, trash or recyclable materials. An officer has probable cause to issue such a citation when a person is seen opening a lid and rummaging through contents of a dumpster or trash can."

Kelly, who spent about nine years in Navy, says he does not plan to stay in Houston, but has nowhere to live at this time.

VA Struggles To Handle Veterans' Claims

The VA is failing to keep up with a torrent of benefits claims, and the backlog leaves many service members high and dry for well over a year after first filing their forms, a new report from the Center for Investigative Reporting (CIR) finds.

From the CIR report: "The agency tracks and widely reports the average wait time: 273 days. But the internal data indicates that Veterans filing their first claim, including those who served in Iraq and Afghanistan, wait nearly two months longer, between 316 and 327 days. Those filing for the first time in America's major population centers wait up to twice as long - 642 days in New York, 619 days in Los Angeles and 542 days in Chicago. The ranks of Veterans waiting more than a year for their benefits grew from 11,000 in 2009, the first year of Obama's presidency, to 245,000 in December - an increase of more than 2,000 percent.

And the VA is predicting that the situation will get worse, as the number of Veterans waiting on the VA to process their claims is expected to surge past the current 900,000 and toward a million by the end of March.

A spokesman for the VA told the CIR that the VA is being inundated by a nearly 50-percent increase in the number of filed claims. He said the growth was due to a combination of increasing numbers of Iraq and Afghanistan Veterans returning home, broadening claims for PTSD and Gulf War illness, and new guidelines allowing Vietnam Vets to request compensation for complications due to exposure to Agent Orange.

The department is also being crushed, quite literally, under claims filed on paper. The CIR reports that 97 percent of all Veterans claims are submitted on paper, a trend that recently led the VA to warn that the weight of the files and cabinets had compromised the structural integrity of one of its office buildings in North Carolina.

> The VA acknowledged that its performance was lagging in a recent hearing before the Senate Comm on Veterans Affairs. "Too many Veterans still have to wait too long to get the compensation benefits they earn, and that is unacceptable to us," VA Undersecretary for Benefits Allison Hickey said. But others are calling for more immediate action. In a column in **Time** magazine, Joe Klein argued that it was time for VA Secretary Eric Shinseki to "step down."

When Chinese Communist Forces viciously attacked friendly elements, Chaplain Kapaun calmly walked through withering enemy fire in order to provide comfort and medical aid to his comrades.

Recognition Coming For Britain's World War II Heroes

World War II war heroes who served on the Arctic Convoys and in Bomber Command will begin receiving brand new awards in recognition of their heroism and bravery within weeks, Defense Minister Mark Francois has announced.

Production of the new Arctic Star and Bomber Command clasp will kick start this week. Up to a quarter of a million Veterans and the families of those who have died could be eligible to receive the new awards in recognition of their unique contribution protecting Britain during World War II. Living Veterans and widows will be the first in line to receive the new awards from as early as March.

Eligible Veterans and next of kin are encouraged to apply for the new awards. Details and an application form can be found at <u>www.Veteransuk.info</u>

The USAF retired its first operational KC-135R tankers from service after more than 50 years of flying it, announced officials at Altus AFB, Okla.

This KC-135, tail number 61-0312, first flew on Aug 14, 1962, got new engines in 1985, and piled up some 22,500 flying hours over the years, states the Feb. 22 release from Altus' 97th Air Mobility Wing, which trains KC-135 air crews. The aircraft departed Altus for good on Feb. 21, en route to the aircraft boneyard at Davis-Monthan AFB, Ariz.

Aircraft 312 is one of the KC-135s that the Fiscal 2013 Defense Authorization Act allows the Air Force to retire.

Gun Control Supporter Backed By New York Mayor Wins Chicago Vote

Gun control supporter Robin Kelly won the Democratic primary for a Chicago area U.S. House seat, propelled by more than \$2 million in TV ads highlighting the guns issue bankrolled by NYC Mayor Michael Bloomberg. Vietnam Veteran Gets Bronze Star



Placido Salazar, a retired airman, earlier this month received the Bronze Star Medal with Valor device for his heroic actions when his air base came under attack in South Vietnam in 1965.

Ret. Col Colin Chauret, former commander of Salazar, pinned the Bronze Star on Salazar during the Feb. 15 ceremony at Joint Base San Anotnio-Randolph, TX. Salazar also received a Purple Heart at the ceremony.

On Aug. 21, 1965, Salazar, who decrypted classified messages as a member of the 4080th Strategic Reconnaissance Wing, at Davis-Monthan AFB, Ariz., was deployed to Bien Hoa Air Base, South Vietnam. The base came under attack. Salazar secured an encrypted message he was holding and then brought his previously injured commander from a nearby building to the underground command post bunker. Salazar then helped two other senior officers to safety in the face of the enemy fire. At one point during the firefight, Salazar was knocked unconscious after slipping. Upon waking, he secured more officers and then guarded the command post until relieved.

Salazar retired from the U.S. Air Force in 1976, after 20 years of service.

Old America Is Gone... And, Sad For The World, It Is Not Coming Back

This article appeared in The Israel National News, and is directed to Jewish readership. 70% of American Jews vote as Democrats. The Rabbi has some interesting comments in that regard.

"The most charitable way of explaining the election results of 2012 is that Americans voted for the status quo - for the incumbent President and for a divided Congress. They must enjoy gridlock, partisanship, incompetence, economic stagnation and avoidance of responsibility. And fewer people voted.

But as we awake from the nightmare, it is important to eschew the facile explanations for the Romney defeat that will prevail among the chattering classes. Romney did not lose because of the effects of Hurricane Sandy that devastated this area, nor did he lose because he ran a poor campaign, nor did he lose because the Republicans could have chosen better candidates, nor did he lose because Obama benefited from a slight uptick in the economy due to the business cycle. Romney lost because he didn't get enough votes to win.

That might seem obvious, but not for the obvious reasons. Romney lost because the conservative virtues - the traditional American virtues - of liberty, hard work, free enterprise, private initiative and aspirations to moral greatness - no longer inspire or animate a majority of the electorate.

The simplest reason why Romney lost was because it is impossible to compete against free stuff.

Every businessman knows this; that is why the "loss leader" or the giveaway is such a powerful marketing tool. Obama's America is one in which free stuff is given away: the adults among the 47,000,000 on food stamps clearly recognized for whom they should vote, and so they did, by the tens of millions; those who - courtesy of Obama - receive two full years of unemployment benefits (which, of course, both desensitizes looking for work and also motivates people to work off the books while collecting their windfall) surely know for whom to vote. The lure of free stuff is irresistible.

The defining moment of the whole campaign was the revelation of the secretly-recorded video in which Romney acknowledged the difficulty of winning an election in which "47% of the people" start off against him because they pay no taxes and just receive money - "free stuff" - from the government.

Almost half of the population has no skin in the game - they don't care about high taxes, promoting business, or creating jobs, nor do they care that the money for their free stuff is being borrowed from their children and from the Chinese.

They just want the free stuff that comes their way at someone else's expense. In the end, that 47% leaves very little margin for error for any Republican, and does not bode well for the future.

It is impossible to imagine a conservative candidate winning against such overwhelming odds. People do vote their pocketbooks. In essence, the people vote for a Congress who will not raise their taxes, and for a President who will give them free stuff, never mind who has to pay for it.

That engenders the second reason why Romney lost: the inescapable conclusion that the electorate is ignorant and uninformed. Indeed, it does not pay to be an informed voter, because most other voters - the clear majority - are unintelligent and easily swayed by emotion and raw populism.

Obama also proved again that negative ads works, invective sells, and harsh personal attacks succeed. That Romney never engaged in such diatribes points to his essential goodness as a person; his "negative ads" were simple facts, never personal abuse - facts about high unemployment, lower takehome pay, a loss of American power and prestige abroad, a lack of leadership, etc. As a politician, though, Romney failed because he did not embrace the devil's bargain of making unsustainable promises.

It turned out that it was not possible for Romney and Ryan - people of substance, depth and ideas - to compete with the shallow populism and platitudes of their opponents. Obama mastered the politics of envy - of class warfare - never reaching out to Americans as such but to individual groups, and cobbling together a winning majority from these minority groups. If an Obama could not be defeated - with his record and his vision of America, in which free stuff seduces voters - it is hard to envision any change in the future.

The road to Hillary Clinton in 2016 and to a European-socialist economy - those very economies that are collapsing today in Europe - is paved.

For Jews, mostly assimilated anyway and staunch Democrats, the results demonstrate again that liberalism is their Torah. Almost 70% voted for a president widely perceived by Israelis and most committed Jews as hostile to Israel. They voted to secure Obama's future at America's expense and at Israel's expense - in effect, preferring Obama to Netanyahu by a wide margin.

Dangerous times ahead, under present conditions, it is inconceivable that the US will take any aggressive action against Iran and will more likely thwart any Israeli initiative. The US will preach the importance of negotiations up until the production of the first Iranian nuclear weapon - and then state that the world must learn to live with this new reality.

But this election should be a wake-up call to Jews. There is no permanent empire, nor is there is an enduring haven for Jews anywhere in the exile. The American empire began to decline in 2007, and the deterioration has been exacerbated in the last five years. This election only hastens that decline. Society is permeated with sloth, greed, envy and materialistic excess. It has lost its moorings and its moral foundations. The takers outnumber the givers, and that will only increase in years to come.

The "Occupy" riots across this country in the last two years were mere dress rehearsals for what lies ahead - years of unrest sparked by the increasing discontent of the unsuccessful who want to seize the fruits and the bounty of the successful, and do not appreciate the slow pace of redistribution.

If this election proves one thing, it is that the Old America is gone. And, sad for the world, it is not coming back."

DOD Bypasses Congress - Again

The Chaplain Alliance for Religious Liberty, an organization of chaplain endorsers, is expressing dismay that the Department of Defense issued a policy memorandum Monday extending benefits to "same-sex domestic partners" of military members without notifying Congress.

The memorandum allows service members to fill out a one-page form stating they are in a domestic relationship with a person of the same sex. The form allows the named partner to receive a DOD Dependent ID card, which then qualifies the named dependent to an array of benefits previously granted only to military spouses. Heterosexual partners are not eligible under the policy.

"This new policy makes a mockery of the Defense of Marriage Act that is still the law of this nation," said Chaplain (Col.) Ron Crews, USAR (Ret.), executive director of the Chaplain Alliance for Religious Liberty. "It is an outrage that the Department of Defense would provide benefits to an unknown number of persons, at significant cost to the military, at a time when the military's budget is being reduced. It is even worse that this is being done without consulting Congress."

New benefits provided to domestic partners by this policy change include a DOD Identification Card, commissary privileges, family center programs, joint duty assignments, disability and death compensation, space-available travel, child care, legal assistance, and other benefits.

State's Legislature Addresses Bills Intended To Enhance Wyoming's 'Military Friendliness'



A Pentagon chart in Washington, D.C., marks Wyoming with a red dot, targeting the state for its failure to give consideration to military members and their spouses who seek professional licenses.

The state House Committee on Transportation, Highways and Military Affairs has attempted to get the red dot removed by voting unanimously in favor of two bills:

- Senate File 130 provides for the consideration of military education and training when people leaving the military or civil service jobs apply for professional or occupational licenses. It affects people with military service in the Army, Navy, Air Force, Marines, Coast Guard, the United States Public Health Service Commissioned Corps, the National Oceanic and Atmospheric Administration (NOAA)'s Commissioned Corps, the National Guard and any reserve or auxiliary component of any of these services.

- Senate File 74 allows military spouses credit for full-time or part-time work experience when applying for a professional or occupational license.

The bills, which previously passed the state Senate, are among six proposals moving through the Legislature that are designed to help military veterans.

During a committee hearing, Wyoming's adjutant general, Maj. Gen. Luke Reiner, said the proposals reflect two specific criteria the Pentagon uses in measuring whether a state is friendly to the military.

Holly Galloway told the committee she is a Gold Star mother whose other son is leaving the Marine Corps after eight years of duty. A Gold Star acknowledges a mother who lost a son or daughter on active duty with the U.S. armed forces. Her surviving son, she said, wants to go to school but is not looking at Wyoming because the state isn't friendly to the military.

Afghanistan Can't Handle Direct U.S. Aid, Watchdog Says

Afghanistan's government does not appear able to manage the large amounts of direct aid that the United States and other countries have pledged, the U.S. watchdog monitoring funds spent on Afghan reconstruction said. John Sopko, the Special Inspector General for Afghan Reconstruction, raised a red flag over U.S. plans to give Kabul billions of dollars more in direct aid instead of providing assistance through contractors and non-governmental organizations operating on behalf of the American government.

U.S. Navy SEAL Who Killed Bin Laden Reportedly Left Without Insurance



The U.S. Navy SEALs' Team Six member who shot and killed Osama bin Laden has opened up about the hardships of life after the mission.

In an interview with **Esquire** titled, **The Man Who Killed Osama bin Laden is Screwed**, the former SEAL told journalist Phil Bronstein that upon leaving the service in September 2012, he lost benefits ranging from current health care to a future pension. And now he's stuck in a months-long wait for his disability claim to be considered.

He had survived his last deployment, and there was a barbecue near his house to celebrate with about thirty close friends from "the community." The Redskins were on, his favorite team, and there was lots of Commando ale, brewed by a former SEAL.

"I left the SEALs on Friday," he said. It was a little more than thirty-six months before the official retirement requirement of twenty years of service. "My health care for me and my family stopped at midnight on Friday night. I asked if there was some transition from my Tricare to Blue Cross Blue Shield. They said 'no.' You're out of the service, your coverage is over. Thanks for your sixteen years. Go frak yourself."

The Center for Investigative Reporting (CIR), for which Bronstein serves as executive chairman, notes that this SEAL's case falls in line with 820,000 instances in which veterans are mired in a backlog for disability help. "It was nearly impossible to believe when he first told me he got such a dearth of support from the U.S. Government," Bronstein said in the CIR report. "Where's the 'thank you?"

In an interview with NBC's **Today Show**, Bronstein spoke with host Matt Lauer about the crux of his **Esquire** piece - the post-military struggles that veterans face. Even if the SEAL had served a full two decades, Bronstein told **Today** that he would have received just \$2,197 per month. A Navy chorus member with that time of service is eligible for the same package. "It's a nine-month average wait for regular vets to get their disability claim adjudicated," Bronstein said. "In this guy's case, his health care that he got, called Tricare from the military, ended the night he left. He gets no pension, none, zero."

"So the guy in the Navy choir gets the exact same pension as the guy we're asking to be the new face of warfare around the world?" Lauer remarked. "Yes, exactly," Bronstein replied.

Stars and Stripes posted a story yesterday evening, charging that the **Esquire** piece's claim of no available military health care options is inaccurate. The independent U.S. military news source points to a Department of Veterans Affairs program which provides five years of free health coverage postdischarge. When asked by **Stars and Stripes** about that option, **Bronstein stood by his reporting, adding** *that no one ever told the SEAL "that this is available."*

A previous headline stated that the former Navy SEAL was reportedly uninsured. The **Esquire** article

Coming Soon Under The Sequester

The U.S. Air Force would lose more than 200,000 flying hours for the remainder of Fiscal 2013 if budget sequestration is implemented on March 1, resulting in a devastating loss of readiness, Chief of Staff Gen. Mark Welsh, III, told members of the Senate Armed Services Committee yesterday.

Service leaders will do everything in their power to protect flying operations in Afghanistan as well as nuclear deterrence and initial flight training, said Welsh. However, "Roughly two-thirds of our active duty combat air force units will curtail home station training, beginning in March, and we'll drop below acceptable readiness levels by mid-May," he said during the SASC's hearing on sequestration's impact on the U.S. military. "Most will be completely nonmission capable by July," he noted.

Under the sequester, the USAF would be forced to postpone depot maintenance work in this fiscal year on about 150 aircraft and 85 engines - a move that would create "a backlog that could take years for us to recover" from, said Welsh. And, roughly 180,000 Air Force civilians will face an involuntary

The Department of Defense's Inspector General has found that an Air Force report stating pilot error as the cause of a fatal 2010 crash of an F-22 Raptor "is not supported by the facts."

The report examined the crash of that took place in Alaska in November 2010, and killed the pilot, Captain Jeff Haney. The crash preceded an Air Force investigation that sought to determine why dozens of Raptor pilots reported suffering from hypoxia-like symptoms while flying the fighter.

The Air Force released its review of the crash in December 2011, discounting oxygen deprivation as a contributing factor and stating that "clear and convincing evidence" showed the crash was the result of Haney's failure to recognize and correct inadvertent control inputs in a timely manner.

The IG said the conclusion failed to meet the Air Force's standards for "clear and convincing" proof, and recommended that the matter be revisited.

Airman Saves Life, Earns City's Recognition By Eric M. White, 910th Airlift Wing Public Affairs



In the early morning, you're driving through the city when you see two men pushing a stalled vehicle. You stop to see if they need help, and another vehicle strikes the two men against their car, fracturing one man's leg and severing the other's below the knee. The victim with the severed leg is bleeding profusely and showing signs of shock. What do you do?

The morning of Feb. 5, 2013, Senior Airman Steve Cresanto, an air transportation journeyman with the Youngstown (Ohio) Air Reserve Station's 76th Aerial Port Squadron, was driving through the city when this scenario became reality, forcing him to make quick decisions.

Jawkwan Rudolph, one of the victims, had the most serious injuries. "His leg was amputated," Cresanto said. "You want to stop the hemorrhaging, so I applied a tourniquet. I didn't have a tourniquet there, so I made one. I made the tourniquet out of the individual's belt and a windshield wiper from the car that struck them," Cresanto said. Cresanto then fashioned a splint for the second victim's fractured leg using an ice scraper and another belt.

When first responders arrived at the scene of the accident, they asked Cresanto where he learned to do what he did, stating that his actions likely saved Rudolph's life. Cresanto credited the self-aid and buddy care training he receives annually as an Air Force reservist. "We do it every single year, do the training, and I never thought I would actually use it in the field. It turns out I did, and I am glad I had the training," Cresanto said.

SABC training includes basic life support and limbsaving techniques to help injured persons survive until medical help arrives.

Charles Sammarone, Youngstown's mayor, presented Cresanto with an award on behalf of the city at a City Council meeting on March 6.

Detective Sgt. Patricia Garcar, one of the first responders to the accident, recommended Cresanto for the award and presented at the council meeting her account of what unfolded the morning of the accident.

"I was just so impressed with what he did," Garcar said. "He did not have to stop and didn't have to offer the assistance that he did, and it just amazed me."

Cresanto is one of more than 1,600 citizen-airmen stationed at Youngstown ARS. "This is just another amazing example of the airmen that we have here and the tie that we have to the community," said Col. James D. Dignan, the 910th Airlift Wing's commander. "There's a sense of family here at the 910th Airlift Wing."
