




Report: DOD To Stop Sending Expended **Brass To Ammo Dealers**



Georgia Arms is the 5th largest retailer of .223 ammunition in America. They sell 9-mm, .45, and .223 ammunition.

They normally buy spent brass from the U.S. Department of Defense. Spent brass is "one time used" shell cases used by our military for training purposes. They buy the brass, recondition it, and then reload the brass for resale to law enforcement, gun clubs, gun shops, and stores like Walmart. They normally buy 30,000 lbs. of spent brass at a time.

This week, the DOD wrote a letter to the owner of Georgia Arms and informed him that from now on the DOD will be destroying the spent brass, by shredding it. It will no longer be available to the ammo-makers, unless they buy it in a scrap shredded condition (which they have no use for).

The shredded brass is now going to be sold by the was severely injured in 2004 in a roadside bomb DOD to China as scrap metal, after the DOD pays for it to be shredded. The DOD is selling the brass to China for less money than the ammo-makers have been paying, plus the DOD has to pay to have the

> Georgia Arms' owner even related a story that one of his competitors had already purchased a load of brass last week. The DOD contacted him this week and said they were sending someone over to make sure it was destroyed - shell cases he had already bought. The brass has no value to the ammo-maker if it is destroyed/shredded/melted.

> The ammo manufacturer only uses the empty brass cases to reload different calibers, mainly .223 bullets.

> The owner of Georgia Arms says that he will have to lay off at least half of his 60 workers within 2 to 3 months if the DOD will no longer sell spent brass cases to the industry. Georgia Arms has 2 to 3 months of inventory to use; by summer they're out.

> If the reloading industry has to purchase new manufactured brass cases, then the cost of ammunition will double or even triple, plus Obama wants to add a 500% tax on each shell.

Veterans Sick From Agent Orange **Poisoned Planes Still Seek Justice**



After a fleet of C-123 airplanes dropped more than 10 million gallons of Agent Orange to destroy enemy cover and crops during the Vietnam War, the military found post-war work for the planes in the U.S. Air Force Reserve.

Retired Lt Col. Paul Bailey belonged to one of those reserve units. Today, he has terminal cancer and, like his sick former co-workers, he has been denied by the Department of Veterans Affairs (VA) for Agent Orange-related Veterans benefits, despite expert opinions that he was likely exposed to the lingering toxic herbicide.

"Magically, once the planes left Vietnam they were no longer contaminated," said Bailey, criticizing what he sees as irrational government policy. "It's frustrating."

Between 1972 and 1982, about 1,500 men and women served aboard 34 C-123s that were previously deployed in Operation Ranch Hand, a large-scale defoliation mission in Vietnam and other countries in Southeast Asia. The planes underwent no testing or decontamination between their decade of spraying and their new state-side assignments with the Air Force Reserve, according to retired Maj. Wes Carter, who himself served aboard C-123s and has been conducting research on their toxic history. Air Force Reserve Veterans also recall no warnings about contamination, or equipment to protect them from any potential aftereffects. Presumably, their superiors were themselves unaware of any danger.

Deemed ineligible by the Department of Veterans Affairs for benefits related to their illness, what haunts these sick Veterans to this day is what they perceive as injustice. The VA maintains that carcinogenic dioxin and other components of Agent Orange could not have posed health risks after Vietnam - only during their use in the war. "Even though residual Agent Orange may be detected in C-123 aircraft by laboratory techniques years after Agent Orange use, any residual [dioxin] in the aircraft would have solidified and be unable to enter the human body in any significant amount," Meagan Lutz, a VA spokeswoman, said.

Yet a number of leading scientists and federal officials refute the VA's claims - calling them "ludicrous," "outrageous," even "preposterous."

Jeanne Stellman, an Agent Orange expert at Columbia University's Mailman School of Public Health, explained that dried dioxin from Agent Orange will escape back into the air and cling to dust. "It looks like the Air Force and the VA has placed their faith in some sort of mysterious new state of matter that is neither solid, nor liquid, nor gas," Stellman said.

chemistry, about toxicology," Fred Berman, director of the Oregon Health and Science University's CROET Toxicology Information Center, said in response to the Air Force position. "These Vets were not immune. They were exposed, yet we're denying them compensation? That doesn't seem fair."

Stellman and Berman were among 14 high-ranking doctors, toxicologists and environmental scientists who signed a letter in November 2012 criticizing the VA's policy. A few have also authored a formal scientific paper on the lingering health hazards of Agent Orange, currently under peer review.

Fighter Squadron Inactivation Signals End Of A-10s In Europe By Staff Sgt. Daryl Knee, 52nd Fighter Wing PA



The U.S. Air Force inactivated the 81st Fighter Squadron on June 18th, at Spangdahelm AB, Germany,, in support of force-shaping procedures across the service.

The squadron employed the A-10 Thunderbolt II, and the closure signals the end of A-10 operations in Europe. "For 71 years, the men and women of this fine squadron have ensured America's security," said Col. David Lyons, the 52nd Operations Group's commander. "The 81st Fighter Squadron piloted many of the most iconic and legendary aircraft the world has ever seen. It leaves me with one thought - that whatever was provided or whatever mission was demanded, the squadron delivered without question and without fail."

Fiscal constraints stemming from the Budget Control Act of 2011, and reduced defense funding outlined in the 2013 Obama's budget required the Air Force to develop a strategic vision for future operations during this financial crisis. In other words, the Air Force merged missions, and cut manning and equipment to stay within its approved budget.

"It's important to know that even though we are closing the doors on our building, the people who worked within the squadron continue to train to increase the combat capability of our Air Force," said Lt. Col. Clint Eichelberger, the 81st FS' commander. "Specifically, in our case, many of these people will focus on becoming the close-air-support experts that are needed down range to accomplish the mission." Technology In Place For Submission Of Veterans Disability Claims

A new online application from the VA enables disability compensation claims to be processed faster in a more end-to-end electronic environment, and VA is urging Veterans and their Veterans' service organization (VSO) representatives to make full use of its capabilities to receive speedier decisions and reduce the backlog of claims.

The availability of the joint VA-Department of Defense Web portal eBenefits, which now integrates with the new internal Veterans Benefits Management System (VBMS) electronic claims processing system, marks a major milestone in VA's transformation from paper claims records to a fully digital operating environment, one of the keys to VA's goal to eliminate the disability claims backlog by the end of 2015. VBMS has now been fielded at all 56 Regional Offices across the country, ahead of schedule. VA will continue to upgrade and improve VBMS based on user feedback, and add features and tools that make it faster and easier to process claims. Instead of filling out and mailing paper forms to VA, Veterans can now use eBenefits to enter claim information online using a step-by-step, interview-style application, with pre-populated data fields and dropdown menus similar to popular tax preparation software.

"There are many advantages to making this move from paper to digital for both Veterans and VA, said Undersecretary for Benefits Allison A. Hickey. "Veterans can now file their claims online through eBenefits like they might do their taxes online."

Filing electronically, any compensation benefits that are awarded will be effective back to the date the Veteran started entering their claim information in eBenefits. From that initial claim establishment date, each Veteran has up to a year to gather all necessary records and hit "submit" to preserve their original date of claim.

eBenefits allows veterans to upload digital images of records and evidence to support their

claims, bypassing the need to physically mail in personal records and wait for confirmation of receipt.

VA is advising Veterans to gather and submit all relevant medical records and file a Fully Developed Claim (FDC) in eBenefits, which entails entering all available evidence at the time the claim is submitted and verifying to VA that they have no more evidence to submit. Veterans filing an FDC will receive priority processing over the traditional claims process. VA can typically process FDCs in half the time it takes for a traditionally filed claim, and there is no risk to Veterans in filing an FDC. If VA finds that there is a piece of relevant evidence that was not submitted by the Veteran, but is needed for a rating decision (like private medical records), claims processors will work to obtain that evidence on the Veteran's behalf and process the claim in the traditional way.

A free premium eBenefits account is required to file claims electronically. The quickest and most convenient method of establishing a free premium eBenefits account is to complete the remote verification process through the eBenefits home page, or use the DOD's common access card (CAC) to register for and/or upgrade to a free premium account. Veterans can also establish an account by telephone at 1-800-827-1000, option 7, if they are in receipt of VA benefits via direct deposit, or by visiting a VA regional office or TRICARE Service Center (if they are a military retiree). For the location of the nearest VA regional office, visit <u>www.va.gov</u> and search the VA regional benefits office locator.

In April, VA announced an initiative to expedite compensation claims decisions for Veterans who have waited one year or longer. On April 19, VA began prioritizing claims decisions for Veterans who have been waiting the longest by providing decisions based on evidence currently in hand that allow eligible Veterans to begin collecting compensation benefits quickly while waiting for their final eligibility decision.

U.S. Supreme Court Rules Your Right To Remain Silent Can Be Used Against You



In a 5-4 decision by the U.S. Supreme Court on June 17th, they ruled that a potential defendant's silence can be used against him if he is being interviewed by police, but has not yet been arrested and read his Miranda rights, nor invoked the Fifth Amendment. Apparently the high Court doesn't consider rights unalienable as something you automatically have, unless you say so.

"You have the right to remain silent, right to a lawyer if you cannot afford one and anything you say can be used against you in court, etc." However, those rights are in effect whether read to you or not. How Many United States Uniformed Services Are There?



This is a very simple question, everyone knows there are five groups; the Army, Marine Corps, Navy, Air Force and Coast Guard. Unfortunately, everyone would be wrong giving this answer. There are two now when and IF the program becomes financially more for a total of seven: The USPHS (United States Public Health Service Commissioned Corps) and NOAA (the National Oceanic and Atmospheric Administration Commissioned Corps).

There are four executive departments responsible for the operation of the seven services: thec United States Department of Defense, the United States Department of Homeland Security, the United States Department of Health and Human Services, and the United States Department of Commerce.

The Army, Navy, Marine Corps, and Air Force are grouped under the Department of Defense. Interestingly, the order of precedence is not based on the date of origin for these services.

The Army was formed on June 14, 1775, the Navy on October 13, 1775, the Marine Corps on November 10, 1775, and the Air Force September 18, 1947, but the order of precedence set by a DOD Directive is: Army, Marine Corps, Navy and Air Force. These are our full-time combat forces and are responsible for the defense and protection of United States soil, citizens and property at home or anywhere in the world.

The Coast Guard was formed on August 4, 1790, and is now under the Department of Homeland Security. It has previously been under the Department of Transportation and the Department of the Treasury. The Coast Guard is sometimes called the "Shallow Water Sailors," but since its founding by Alexander Hamilton, it has been the oldest continuous seagoing service. In times of war, it can be and has been transferred to the Department of the Navy. The Coast Guard has been involved in every war from 1790 to believe their freedoms are being threatened." Iraq and Afghanistan.

Commissioned Corps was formed on Jan. 4, 1889, and is now under the Department of Health and Human Services. It is a non-combatant service and all members are commissioned officers who wear uniforms based on U.S. Navy uniforms. This group is under the command of the U.S. Surgeon General, who holds the rank of vice admiral. Its purpose is to provide health care to populations in the U.S. who would be considered medically under-served by normal standards because of location or special needs. It also has the responsibility of identifying health hazards and removing the threats that might exist from them. Officers in this group can be detailed to other groups as advisors or for research purposes when needed. They also function as part of the Emergency Response Plan in times of natural disasters or emergency operations. The National Oceanic and Atmospheric Administration Commissioned Corps was formed on May 22, 1917, and is now under the Department of Commerce. It is a non-combatant service and all members are commissioned officers who wear uniforms based on U.S. Navy uniforms. It functions as a scientific agency of trained professionals who work in the fields of engineering, Earth sciences, oceanography, meteorology and other related fields. These are the map-makers, weather people, storm chasers, and fishing forecasters, among other things. Much of their work is done on research projects related to the oceans and our environment. So, these are our seven Uniformed Service Groups as they presently stand. Some like the Army have pretty much remained the same since the first formation. Others like the Coast Guard have worn out their walls hanging and re-hanging pictures of their organizational charts and leadership through the years.

Ron Crews, USAR (Ret.), executive director for Chaplain Alliance for Religious Liberty. "To ensure our men and women in uniform are able to exercise their sincerely held religious beliefs, we are making 'Religious Liberty Palm Cards' available to chaplains and all service men and women. The cards outline what service members' constitutionally protected religious liberties are and what to do if they

"We have also established a link on our website The United States Public Health Service that will provide a place for those who have encountered problems to report their concerns," Crews added. "We have enlisted experienced attorneys as well as retired chaplains to provide counsel and encouragement."

> The Chaplain Alliance for Religious Liberty is joining with others to support amendments that the full House of Representatives and the Senate Armed Services Committee recently passed. These amendments make clear that religious liberty protects the religious actions and speech of those in the military. "This language is necessary because it appears that some in the Department of Defense mistakenly understand religious liberty to protect only one's beliefs, rather than the resulting actions and speech based on one's beliefs," Crews explained. "To believe is to live out your beliefs, to express your beliefs. These amendments are carefully worded to respect good order and discipline while protecting the religious liberty of our men and women in uniform."

Missouri's Governor Vetoes Bill That Nullified Federal Gun Laws

Saying Missouri cannot overrule federal law, Gov. Jay Nixon has vetoed a bill that sought to make it a crime for federal agents to enforce gun control laws.

Nixon said state legislators were trying "to resurrect the pre-Civil War concept of nullification," which argues that states can determine if a federal law is constitutional. "Of course, an individual state is not empowered to determine which laws it will comply with, nor is it empowered to declare a federal act to be unconstitutional," Nixon wrote in his veto message.

In addition to violating the supremacy clause, the governor said the bill passed by the Legislature would have violated the constitutional right to free speech by making it a crime to publish the names of people who own guns. That provision could have sent reporters to jail for a year for printing photos of local gun rights rallies or young Missourians proudly posing with their first turkey or deer, Nixon said.

Republicans, who control the Legislature, criticized the Democratic governor's veto and said they might try to override it in September. The bill passed in May on votes of 116-38 in the House and 26-6 in the Senate more than the two-thirds majorities needed to enact a bill over a governor's veto. An override requires 109 votes in the House and 23 in the Senate.

Supporters said the bill would protect residents from over-reaching federal laws and proposals to ban assault weapons and expand background checks. "The federal government has been proven for decades to be putting unreasonable regulation over our Second Amendment rights," the bill's sponsor, Rep. Doug Funderburk (R-St. Peters), said. "What I'm attempting to do is to bring some of that authority back to the state, as our founding fathers always intended it to be."

At issue is a 26-page bill that declared all federal laws and rules - "whether past, present or future" invalid if they infringed on the constitutional right to bear arms. Included in that category were gun control laws passed by Congress in 1934 and 1968, as well as any gun and ammunition tracking laws that "could have a chilling effect on the purchase or ownership of those items by law-abiding citizens."

Federal agents who enforced the laws in Missouri could have been charged with misdemeanors, punishable by up to a year in jail and a \$1,000 fine. The bill also would have lowered to 19 from 21 the age for people to obtain permits to carry concealed guns.

Under another provision, school districts could have designated teachers who hold concealed-gun permits as "school protection officers." They would have been allowed to carry guns in schools.

While nullification advocates have argued that states have the final word on what is constitutional, Nixon said the U.S. Supreme Court had consistently held otherwise, beginning with the 1803 landmark case of Marbury vs. Madison, which established the foundation for judicial review.

Nixon, who cut the ribbon at the opening of the NRA convention in St. Louis last year, has long tried to walk a political tightrope on gun legislation. He did sign a narrower gun rights bill That will let state employees keep guns in their locked cars on state property. Another provision will bar cities from running gun buy-back programs unless the guns received are later offered for

And in 2010 he signed a bill that broadened the state's "castle doctrine," which allows people who encounter an intruder in their home to use deadly force. "As a gun owner and hunter, I support the Second Amendment rights of Missourians and oppose efforts to undermine them," Nixon said.



U.S. Mulls Complete Withdrawal, Afghan Computer Warning Seeking Money A **Officials Skeptical**



The United States is considering pulling out all its troops from Afghanistan next year, but is far from making a decision, White House and Pentagon officials said, but Afghan officials expressed skepticism that Obama would back a complete withdrawal.

Amid tensions between Obama and Afghan President Hamid Karzai on the path forward, White House spokesman Jay Carney told reporters that a "zero option" of leaving no U.S. troops in Afghanistan after 2014 is among the policy possibilities under consideration.

Pentagon spokesman George Little, in a news briefing, declined comment on whether Defense Secretary Chuck Hagel supported keeping U.S. forces in Afghanistan after 2014, saying he would not disclose Hagel's private recommendations to Obama.

Pentagon Must Overhaul Its Mia Efforts



The investigative arm of Congress says the Pentagon's efforts to find and identify American military members missing from past conflicts are undermined by leadership weaknesses and a fragmented approach.

The report echoes in some respects the criticisms cited in an internal Pentagon study disclosed last week by The Associated Press in which key aspects of the MIA accounting effort were called "dysfunctional."

Today's report by the Government Accountability Office (GAO) was requested by Congress last year. It said the numerous Pentagon organizations that are collectively responsible for accounting for MIAs were directed in 2009 to come up with a plan for how to more than double the rate of MIA identifications by 2015. But the plan is still unfinished, due to what the GAO called a fragmented approach and bureaucratic infighting.

Scam, U.S. Courts Say



A computer virus that locks up personal computers, and then issues a demand for money from the Department of Justice and the U.S. Courts, is a scam and has no link to the courts or other federal agencies. The virus locks up computers and warns users that they face criminal prosecution unless they pay a fee.

Victims should contact the Justice Department's "ransomware hotline," which provides details about the scam and urges victims to file a federal complaint. The hotline's number is (202) 353-0708.

According to the Justice Department hotline, "The message from your computer is a scam. Your computer is infected with a computer virus, created by criminals who are attempting to take your money. It is these criminals, and not the Department of Justice, that have locked your computer."

The hotline informs callers that they must remove the virus to regain function of their computer, and urges callers to file a complaint with the Internet Crime Complaint Center, at <u>www.ic3.gov</u>.

To reduce the risk of being a victim, computer owners should keep all system software updated; use current anti-virus and anti-spyware software; deploy a local firewall; visit only trusted sites on the Internet; and not click on any link received via e-mail from an unknown source.

NAACP Admits Trayvon's Past 'Shaky' By Colin Flaherty, WorldNetDaily

The first mistake the president of the NAACP in Norfolk, Va., made was saying that Trayvon Martin had a "shaky" past. Then Tristan Breaux admonished his membership to react "logically, not racially: to the verdict.

This happened just as the lawyers prepared their closing arguments in the trial of George Zimmerman for the killing of Trayvon. Zimmerman was acquitted over the weekend. Obama's 2013 Air Force One Bill Is \$24 Million - \$6.5 Million For Africa Alone By Phil Bedard, The Washington Examiner



Obama, already the most traveled chief executive in the modern era after internationalist former President George H. W. Bush, is expected to run up an Air Force One tab of at least \$24 million this year alone, according to the National Taxpayers Union Foundation.

Already Obama, just back from a trip with his family and a huge entourage of staff to several African nations, has run up a \$15.2 million bill just for Air Force One in the first six months of 2013. Security and hotel costs can dwarf the jet's cost. Some estimates of the president's Africa trip alone top \$100 million.

The NTUF's Douglas Kellogg told Secrets that Obama's Africa Air Force One bill to taxpayers was \$6,654,345. But unlike those costs which are hard to estimate and often kept secret, Air Force One costs can be calculated based on published hourly figures provided by the Pentagon.

So far, Obama has spent 18 days abroad, is on a pace to surpass is 20 days abroad in 2010 and 2011 and is approaching his high of 40 days in 2009. Total costs so far for Air Force One calculated by the NTUF are \$15,219,433.

The NTUF said that Obama's near 18-hour flight back from Tanzania marks his 14th overseas flight this year.

"Estimating the potential costs of additional trips Obama already has planned for later this year is imprecise, however, using the median cruise speed of Air Force One applied to distances for trips to Moscow, Indonesia, and Brunei, brings the total for Obama's 2013 Air Force One costs to over \$24 million," said the NTUF.

The latest estimate from the NTUF comes just days after the taxpayer's watchdog group released its latest study of presidential travel, "Up in the Air." That study found that Obama has nearly caught up to Bush's travel despite a tough and long reelection campaign in 2012. "Obama nearly spent as many days abroad as the current single presidential term leader, George H. W.

No'Obamacare' Mandate Delay Will Cost \$12 Billion, Affect 1 Million Workers

Obama's decision to delay implementation of part of **his** healthcare reform law will cost those who pay taxes an additional \$12 billion and leave a million fewer Americans with employer-sponsored health insurance in 2014, congressional researchers said.

The report by the non-partisan Congressional Budget Office is the first authoritative estimate of the human and fiscal cost from the administration's unexpected one-year delay announced July 2 of the employer mandate - a requirement for larger businesses to provide health coverage for their workers or pay a penalty.

Under Obama's healthcare reform law, employers with 50 or more full-time workers were supposed to provide healthcare coverage or incur penalties beginning January 1. But the requirement will now begin in 2015.

Marines 'Not Leaving A Single Thing In Afghanistan,' Top General Says

Marines are not planning a repeat showing of the rusting carcasses of Russian military equipment that litter the ground in Afghanistan following its unsuccessful campaign in the 1980s.

The top Marine Corps general said that every single piece of Corps equipment will leave Afghanistan with the troops, or will purposefully be given to another country. The Marines have so far withdrawn almost 70 percent of their equipment.

The Marine Corps needs that equipment back, says Commandant Gen. James Amos, particularly under the current budget squeeze. "We've got to get it out," he said. "Under sequestration, I need to reset it so we can use it."

Continuing these across-the-board cuts could account for a troop reduction in as many as 8,000 Marines, he says.

"I'm not planning on leaving anything. Anything that gets left in that country that has 'USMC' on the side will be purposefully left by Marine Corps Gen. Joseph Dunford, or Army Gen. Lloyd Austin," he said of the commanders of the ISAF and the CENTCOM, respectively. These generals have the authority to give some of this equipment to another country, Amos said. The military learned from Iraq, where equipment inventory was not a top priority. As Amos says, "We had equipment all over the place." Marines sent a specific task force to Iraq for the final 13 months of Operation Iraqi Freedom, which ended in 2011, to organize, repair and move equipment from Iraq into neighboring Kuwait. From there, as much as 60 percent of it went to Afghanistan to support the troop surge that began in 2010.

Def Sec Can't Offer Budget Cuts Hope

Chuck Hagel delivered the news that furloughs, which have forced a 20 percent pay cut on most of the military's civilian work force, probably will continue next year, and it might get worse.

"Those are the facts of life," Hagel told 300 DoD employees, last month at an Air Force reception hall on a military base in Charleston, S.C.

Future lay-offs also are possible for the civilian work force of more than 800,000 employees, Hagel said, if Congress fails to stem the cuts in the next budget year, which starts on Oct. 1.

On the heels of the department's first furlough day, and in three days of visits with members of the Army, Navy, Air Force and Marine Corps, Hagel played the unenviable role of messenger to a frustrated and fearful work force coping with the inevitability of a spending squeeze at the end of more than a decade of constant and costly war. The fiscal crunch also lays bare the politically unpopular, if perhaps necessary, need to bring runaway military costs in line with most of the rest of the American public that has struggled economically for years.

"Everybody's bracing for the impact," Army Master Sgt. Trey Corrales said after Hagel spoke with soldiers during a quick stop at Fort Bragg, N.C.

Corrales' wife, a military civilian employee, is among those furloughed, and they have canceled their cable TV and started carpooling to work to save money. "The effects of the economy have started to hit the military," Corrales said.

The furloughs have hit about 650,000 civilian employees but also have slowed health care and other services for the uniformed military, which has stopped some training missions and faces equipment shortages due to the budget shortfalls. Troops were told this month they will no longer receive extra pay for deployments to 18 former global hot spots no longer considered danger zones.

Troops already are facing force reductions, and the Army alone has announced plans to trim its ranks by 80,000 over the next five years.

MIA Work 'Acutely Dysfunctional'

The Pentagon's effort to account for tens of thousands of Americans missing in action from foreign wars is so inept, mismanaged and wasteful that it risks descending from "dysfunction to total failure," according to an internal study suppressed by military officials.

Largely beyond the public spotlight, the decades-old pursuit of bones and other MIA evidence is sluggish, often duplicative and subjected to too little scientific rigor, the report says.

The Associated Press obtained a copy of the internal study after Freedom of Information Act requests for it by others were denied.

The report paints a picture of a Joint POW/MIA Accounting Command, a military-run group known as JPAC and headed by a two-star general, as woefully inept and even corrupt. The command is digging up too few clues on former battlefields, relying on inaccurate databases and engaging in expensive "boondoggles" in Europe, the study concludes.

In North Korea, the JPAC was snookered into digging up remains between 1996 and 2000 that the North Koreans apparently had taken out of storage and planted in former American fighting positions. DC paid the North Koreans hundreds of thousands of dollars to "support" these excavations.

Some recovered bones had been drilled or cut, suggesting they had been used by the North Koreans to make a lab skeleton. Some of those remains have since been identified, but their compromised condition added time and expense and "cast doubt over all of the evidence recovered" in North Korea, the study said. This practice of "salting" recovery sites was confirmed to the AP by one U.S. participant.

JPAC's leaders authorized the study of its inner workings, but the then-commanding general, Army Maj. Gen. Stephen Tom, disavowed it and suppressed the findings when they were presented by the researcher last year. Now retired, Tom banned its use "for any purpose," saying the probe went beyond its intended scope. His deputy concurred, calling it a "raw, uncensored draft containing some contentious material."

The AP obtained two internal memos describing the decision to bury the report. The memos raised no factual objections but said the command would not consider any of the report's findings or recommendations.

The failings cited by the report reflect one aspect of a broader challenge to achieving a uniquely American mission — accounting for the estimated 83,348 service members still listed as missing from World War II, Korea and Vietnam.

This is about more than tidying up the historical record. It is about fulfilling a promise to the mothers and fathers, sisters and brothers and sons and daughters of the missing. Daughters like Shelia Reese, 62, of Chapel Hill, N.C., who still yearns for the father she never met, the boy soldier who went to war and never returned.

She was 2 months old when heartbreaking word landed at her grandmother's door a week before Christmas 1950 that Pfc. Kenneth F. Reese, a 19year-old artilleryman, was missing in action in North Korea. To this day, the military can't tell her if he was killed in action or died in captivity. His body has never been found. Reese is among 7,910 unaccounted for from Korea, down from 8,200 when the war ended 60 years ago this month. Over time, the obscure govt bureaucracies in charge of the accounting task have largely managed to escape close public scrutiny despite clashing with a growing number of advocacy groups and individuals such as Frank Metersky, a Korean War Veteran who has spent decades pressing for a more aggressive and effective U.S. effort. The outlook for improvement at the Joint POW/MIA Accounting Command, he says, is not encouraging. "Today it's worse than ever," he says. People disagree on the extent of the problem. But even the current JPAC commander, Air Force Maj. Gen. Kelly K. McKeague, says he would not dispute those who say his organization is dysfunctional. "I'd say you're right, and we're doing something about it," McKeague said in a telephone interview last week from his headquarters in Hawaii. He said changes, possibly to include consolidating the accounting bureaucracy and putting its management under the Joint Chiefs of Staff in Washington, are under consideration. The internal report by Paul M. Cole was never meant to be made public. It is unsparing in its criticisms: In recent years the process by which JPAC gathers bones and other material useful for identifications has "collapsed" and is now "acutely dysfunctional." JPAC is finding too few investigative leads, resulting in too few collections of human remains to come even close to achieving Congress's demand for a minimum 200 identifications per year by 2015. Of the 80 identifications that JPAC's Central Identification Laboratory made in 2012, only 35 were derived from remains recovered by JPAC. Thirty-eight of the 80 were either handed over unilaterally by other governments or were disinterred from a U.S. military cemetery. Seven were from a combination of those sources. Some search teams are sent into the field, particularly in Europe, on what amount to boondoggles. No one is held to account for "a pattern of foreign travel, accommodations and activities paid for by public funds that are ultimately unnecessary, excessive, inefficient or unproductive." Some refer to this as "military tourism."

"Sketch maps" used by the JPAC teams looking for remains on the battlefield are "chronically unreliable," leaving the teams "cartigraphically blind." Cole likened this to 19th century military field operations.


Absent prompt and significant change, "the descent from dysfunction to total failure... is inevitable," Cole concluded.

He directed most of his criticism at the field operations that collect bones and other material, as opposed to the laboratory scientists at JPAC who use that material to identify the remains. Cole is a management consultant and recognized research expert in the field of accounting for war remains; he still works at JPAC.

More broadly, the govt organizations responsible for the accounting mission, including the Pentagon's Defense Prisoner of War/Missing Personnel Office, or DPMO, which is in charge of policy, have sometimes complicated their task by making public statements that their critics view as disingenuous or erroneous.

The Pentagon Could Have Its First Female Navy Seals By 2016



The Pentagon has specific plans to remove the remaining restrictions that have kept female soldiers from combat and other positions near the front lines. The plans, likely to be formally unveiled later today, will include reviewing - and likely changing - the physical and mental standards that men and women need to meet in order to qualify for certain positions across the four branches, and would set one common standard for both sexes for each specific job.

The plans also include the rough outline for when women could become a Navy SEAL or Army Ranger, two of the most high-profile and demanding jobs within the military: Under the schedules military leaders delivered to Defense Secretary Chuck Hagel, the Army will develop standards by July 2015 to allow women to train and potentially serve as Rangers, and qualified women could begin training as Navy SEALs by March 2016 if senior leaders agree.

Military leaders have suggested bringing senior women from the officer and enlisted ranks into special forces units first to ensure that younger, lower-ranking women have a support system to help them get through the transition.

The Navy intends to open up its Riverine forces and begin training women next month, with the goal of assigning women to the units by October. While not part of the special operations forces, the coastal Riverine squadrons do close combat and security operations in small boats.

The Navy plans to have studies finished by July 2014 on allowing women to serve as SEALs, and has set October 2015 as the date when women could begin Navy boot camp with the expressed intention of becoming SEALs eventually.

Army officials plan to complete genderneutral standards for the Ranger course by July 2015. Army Rangers are one of the service's special operations units, but many soldiers who go through Ranger training and wear the coveted tab on their shoulders never actually serve in the 75th Ranger Regiment. To be considered a true Ranger, soldiers must serve in the regiment.

Women currently make up about 14 percent of the nation's 1.4 million active military personnel.

The Department of Veterans Affairs (VA) has reached another milestone in its disability claims transformation process - over 30 percent of the current disability claims inventory is now digital and accessible to claim raters in VA's electronic claims processing system, which has now been fielded ahead of schedule at all 56 Regional Offices across the country. U.S. Veteran Returns To North Korea By Jim Corvey, News of the Force St. Louis



Two years after he made history by becoming the Navy's first black pilot, Ensign Jesse Brown lay trapped in his downed fighter plane in subfreezing North Korea, his leg broken and bleeding. His wingman crash-landed to try to save him, and even burned his hands trying to put out the flames.

A chopper hovered nearby. Lt. (j.g.) Thomas Hudner could save himself, but not his friend. With the light fading, the threat of enemy fire all around him and Brown losing consciousness, the white son of a New England grocery-store magnate made a promise to the black son of a sharecropper: "We'll come back for you."

More than 60 years have passed. Hudner is now 88. But he did not forget. He has come back. Hudner, now a retired Navy captain, arrived in Pyongyang today with hopes of traveling in the coming week to the region known in North Korea as the Jangjin Reservoir, accompanied by soldiers from the Korean People's Army, to the spot where Brown died in December 1950. The reservoir was the site of one of the Korean War's deadliest battles for Americans, who knew the place by its Japanese name, Chosin. The snowy mountain region was nicknamed the "Frozen Chosin," and survivors are known in U.S. history books as the "Chosin Few."

The Battle of the Chosin Reservoir lasted for 17

Thanks To License Plate Tracking, The Police Know Where You've Been



The spread of cheap, powerful cameras capable of reading license plates has allowed police to build databases on the movements of millions of Americans over months or even years, according to an American Civil Liberties Union (ACLU) report.

The license-plate readers, which police typically mount along major roadways or on the backs of cruisers, can identify vehicles almost instantly and compare them against "hot lists" of cars that have been stolen or involved in crimes.

But the systems collect records on every license plate they encounter - whether or not they are on hot lists - meaning time and location data are gathered in databases that can be searched by the police. Some departments purge information after a few weeks, some after a few months and some never, said the report, which warns that such data could be abused by the authorities, and chill freedom of speech and association. "Using them to develop vast troves of information on where Americans travel is not an appropriate use," said Catherine Crump, a staff attorney at the ACLU and one of the authors of the report, You are Being Tracked: How License Plate Readers Are Being Used to Record Americans Movements.

The standards by which the authorities may access the data varies. In the Northern California town of Pittsburg, for example, local police may analyze the database for "any routine patrol operation or criminal investigation," and "reasonable suspicion or probable cause is not required," according to the report.

In Scarsdale, NY, the barrier for access "is only limited by the officer's imagination."

The report also illuminates a network of private companies - many in the repossession business - that scan 50 million license plates a month in major metropolitan areas and sell the data to law enforcement agencies. "These huge databases of plate information are not subject to any data security or privacy regulations governing license plate reader data," the report said. "These companies decide who can access license plate data and for what purposes."

major, and other Veterans, told lawmakers that VA's medical staff isn't recognizing signs of sexual abuse in former troops and hasn't been properly treating victims.

The House Veterans' Affairs subcommittee hearing was held two months after the Defense Department released a survey that found military sexual assaults had increased 35 percent in two years. Those health care issues and others are increasingly shifting to the VA as more troops return from war.

The victims who testified said they believed Veterans who have been sexually abused should be treated outside the department because of problems accessing proper care and long waits for VA programs.

While public and political attention has focused on men in uniform abusing women, the military's confidential survey of active duty troops found that more victims of sexual assault and harassment in the military are male, largely because men make up about 85 percent of the total force.

Veteran Brian Lewis, a Navy petty officer third class who said he was raped at knife point, told the subcommittee that the VA is so "fundamentally incapable of providing care" for sexual trauma that some male victims use VA clinics for women. "This is not best practice. This is horrible practice," Lewis said during the hearing. "I also deserve to have my manhood, in essence, respected by not having to seek treatment in a women's clinic."

Rajiv Jain, the VA's assistant deputy undersecretary for patient care, said at the hearing that the department needs to take a "critical look" at its services for sexual trauma victims. "They really present a very powerful story," Jain said of the Veterans who described their struggles getting VA treatment. "We also feel there are significant gaps that have been pointed out by the panel and that we need to really look and see how best we can meet the needs of all our Veterans in a sensitive manner."

The VA provided more than 85,000 veterans with care related to military sexual trauma in the year that ended Sept. 30, Jain said in written testimony submitted to the committee. That's an increase of almost 11 percent from the prior year, according to Jain's prepared testimony.

In May, the Defense Department estimated 26,000 military personnel may have experienced unwanted sexual contact last year, compared with 2,949 victims identified in criminal reports. The same month, three military officers assigned to programs to prevent sexual abuse were removed from their posts after allegations of wrongdoing.







USS Fort Worth Completes Painting



The camouflage painting of **USS Fort Worth** (LCS 3) was completed at Naval Base San Diego's graving dock on June 28.

Workers applied a paint scheme that differs from that used on Fort Worth's sister ship, **USS Freedom** (LCS 1). **Freedom** was painted earlier this year using a pattern based on a World War II-era design prior to her current deployment to Singapore.

"For a commanding officer of the Navy's newest class ship, seeing **Fort Worth** with her new paint scheme is gratifying and exciting," said Cmdr. Hank Kim, commanding officer of **Fort Worth**. "**Fort Worth** is proud to be part of those evolutionary - and revolutionary - concepts that bring LCS closer to full fleet integration. The crew is ready to return to sea and put the paint design to the test."

The paints used are currently within the Navy's supply system. **Fort Worth**'s paint job cost an estimated \$1.41 million, compared to the cost for painting **Freedom**, which was \$1.64 million.

The paint design for **Fort Worth** includes dark shaded paints nearer the waterline of the ship to contrast against the sea surface, and gets progressively lighter further up the ship and above the water's surface to contrast against the area of sky just above horizon. The camouflage paint also uses contrasting angles and slopes to make the ship more difficult to detect visually. Additionally, this paint scheme is designed to be simpler in construct than the paint scheme used on **Freedom**, easier to apply, and visually appealing.



Sgt. Bergdahl was declared Duty Status Whereabouts Unknown (DUSTWUN) on July 1, 2009, and his status was changed to "Missing-Captured" on July 3, 2009. Sgt. Bergdahl is listed as a member of the 1st Battalion, 501st Infantry Regiment, 4th Brigade Combat Team, 25th Infantry Division, from Fort Richardson, Alaska.

Symbol Of Women Marines Dedicated At Marine Corps Museum



"The Molly Marine" statue erected in New Orleans, La., in 1943 symbolizes different qualities to different people. Poise, professionalism, possibility, courage, commitment, faithfulness, sacrifice, honor and integrity were all terms invoked by speakers at the dedication of a replica of Molly now in place at the National Museum of the Marine Corps.

But the statue has long had a personal meaning to Maj. Gen. Angela Salinas, director of the Manpower Management Division of Manpower and Reserve Affairs. She told the crowd gathered in the museum's atrium on July 5, of the 12-inch Molly Marine statue that was given to her on her graduation from recruit training at Marine Corps Recruit Depot Parris Island, S.C., in 1974. The sculpture was awarded to the female recruit who best exemplified the meaning of being a Marine. "She stands as a constant reminder of my roots and the legacy that's been entrusted to me," she said, adding that the statuette gave her the confidence to reach beyond what she would have imagined herself doing. "Molly connects our past with our present and gives us hope for the future," Salinas said.

The original statue, depicting a young woman in uniform, head held high, holding a book and a pair of binoculars, was created to help recruit women during World War II. It was the country's first monument of a female in service uniform. Other replicas stand at Parris Island and in front of the Gray Research Center aboard Marine Corps Base Quantico, Va.

Betty Moseley-Brown, president of the Women Marines Association, which was a major donor to the statue project, said Molly represents the courage and commitment that every female Marine exhibits when she leaves home to volunteer her service. "We stand taller, we walk with a quicker step, we rest easier because of our service and the service of men and women today who are standing the watch," said Moseley-Brown, who is a Marine Corps Veteran.



Big Brother Is Watching And Arresting Taking Pictures In Massachusetts Is Now Illegal

Police have arrested a man after he was seen taking a photograph of U.S. Secretary of State John Kerry's home in Boston, Mass. Authorities found a pellet gun in the man's car parked near the house and arrested the man yesterday for having an open container of alcohol, Kerry spokesman Glen Johnson said in a statement. Kerry was not at home at the time. State Department security officers called the police after the man was spotted taking a picture of a window in Kerry's house, Johnson said.

"Taxpayers... Good Sports!"

The U.S. <u>military has reportedly spent \$34</u> <u>million to build a new complex in Afghanistan but</u> <u>is unlikely to ever actually use the facility</u>.

The Voice of America reports that the unused site came to the attention of a congressional oversight committee that reviews projects in Afghanistan.

"I don't know if [Secretary Chuck Hagel] will provide a formal response. I do not have one at this stage," said Defense Department spokesman George Little when asked about the project. "I think it is going to take us a little bit of time to review the findings and to coordinate with the SIGAR."

(<u>SIGAR</u> stands for the Office of the Special Inspector General for Afghanistan Reconstruction, which described the base as a "potentially troubling example of waste.")

Special Inspector General John Sopko told Congress that some U.S. commanders opposed the 20,000-square-foot installation's construction in 2010. But a year later, a British firm was nonetheless hired to build it. Originally, it was planned to serve as a regional command headquarters in the country's southern region. Technically, it was designed to house 1,500 staff. Iut now, commanders say it's unlikely to ever be occupied by military personnel.

Sopko said that as U.S. forces begin to leave the country, they will be left with two options: destroy the facility or hand it over to Afghan officials. And as of today, at least one person who spent time at the facility thinks demolishing it makes more sense.

"Helmand Province and [the Afghan capital] Kabul may as well be two different countries in a lot of practical ways," <u>Marine Corps Times</u> writer Dan Lamothe told the VOA. "The government is so far removed from the everyday lives of the people in Helmand that I do not see how Kabul would keep track of something like that." Lamothe says the project reminds him of another recent failed venture in the country during which a police station was built with a new septic system. However, the toilets eventually had to be shut down because no one knew how to operate the system.

The revelation of the unused base was followed by another example of potential waste in the country revealed by SIGAR on Thursday. It also was announced that <u>an \$11 million solid-waste</u> <u>trash compactor has gone largely unused, with</u> <u>most trash simply being burned in outdoor piles</u>.


